# **Task 3: Identified Cluster Analysis**

Task 3.1 Business Lists

### INTRODUCTION

As part of Task 3, Identified Cluster Analysis, Solano County business lists have been generated to help identify and segment clusters, industries and targets for business retention and expansion efforts and creating industry groups to address the needs and challenges of specific industries in Solano County.

The clusters and industries identified as primary targets for economic development services are in "traded sectors". Traded sectors and businesses are those that are primarily focused on markets outside Solano County for their revenues.

In addition to Solano County industry lists, lists have also been generated for surrounding counties to assist in tracking industry trends regionally.

 All lists have been delivered to the Solano Economic Development Corporation separately. Local Solano County lists will be uploaded to the new Solano First! Business Retention & Expansion tracking system.

### **BUSINESS LISTS**

The Employment Development Department of California (EDD) publishes employer lists by many characteristics as noted in Chart 1. This becomes the base list for employer tracking.

### **CHART 1 - EDD BASE LIST**

- **■** Company Name;
- Primary Company Address, including City,State, Zip;
- Geo address (latitude and longitude) for mapping purposes;
- Contact info:
  - Phone;
  - In some cases, e-mail;
  - In some cases, website;
- NAICS Code (the normal six digits are indies of a stated 8-digit number where the first six digits are the normal NAICS code);
- Employment size range;
- Sales volume estimate range; and
- Whether a branch or single location.

This data comes directly from the EDD payroll tax listings; the time lag of up to 18 months suggests there will be errors in terms of timely data. The error rate is unknown until verified and cross-checked with other list by EDC staff. While these lists from InfoUSA (purchased by EDD for public use) have a time lag, they are meant to be comprehensive. For this reason, the data can be used as the data foundation and uploaded into the customerrelation management (CRM) software, Solano First! However, different from the business license data, EDD and InfoUSA data can be separated into businesses that represent traded and non-traded (locally-serving) sectors based on NAICS code. Having the NAICS codes available and linked to the ES 202 reporting is key. ES 202 data is also known as the Quarterly Census of Employment and Wages (QCEW) and links NAICS-based data to employment counts, monthly wage levels and corroboration of the number of businesses, as well as governmental agencies and what is being paid there.

Data from InfoUSA and EDD may suffer from having redacted data due to confidentiality. Data is also coded or categorized in ways that do not match across cities or counties and their business lists. Local business license data maybe more timely and updated, however, what gains may be available with the precision and timeliness of the business

license data may be lost with a lack of contact info or other characteristics that is available with the EDD data. Most likely neither list will be complete (based on scofflaws and businesses that do not file payroll).

As time permits for Solano's cities or the EDC, the lists could be merged to identify duplicates and/or missing business to update a master list.

It is likely that the businesses to be retained, identified and potentially attracted, would all be on the EDD lists.

### **NAICS Code Sorting**

The initial base list(s) contain a large amount of businesses for just Solano County. An even larger list, if regional business were included, matches Solano County's commuting laborshed.

The Solano County clusters and targets are Manufacturing, Food & Beverage, Life Sciences and Logistics. Food & Beverage and Life Sciences, such as, pharmaceutical are sub-sets of manufacturing in the NAICS codes.

Manufacturing incorporates all industries starting with two-digit NAICS Code 31 with the following segments within manufacturing at the three-digit NAICS:

Logistics are included in the two-digit NAICS Codes for Transportation, 48.

Industries within these two and three-digit NAICS Codes are further segmented to six-digit codes which provide opportunity to further track and analysis industry activity in Solano and surroundings county.

The power of this data can be shown in Chart 2, High Growth and Declining Industries in Solano County, 2009-14.

# HIGH GROWTH AND DECLINING INDUSTRIES IN SOLANO COUNTY 2009 TO 2014

High growth includes non-retail industries that have added 100 or more jobs in the past five years from 2009 to 2014 <a href="mailto:cnm; and are growing faster than the U.S.">cnm; are growing faster than the U.S.</a> average for that industry. ### **DATA**

The business lists provide a lot of data that is not combined readily in other governmental databases. The NAICS code data and having the structure of these databases available for all 58 counties in California can make for a strong check against other, local databases that may not be as comprehensive (business license lists, as an example).

The following summarizes the make-up of the businesses in Solano County:

- As of the end of 2014 (the lists from InfoUSA are dated 2015 and provide year-end 2014 data), there were 11,772 NAICS identified businesses in Solano County
  - Professional Services businesses;
  - Construction and contractors;
  - Health Services;
  - Real Estate; and
  - Restaurants and Bars.
- As a summary statement, the following business counts existed in surrounding counties and within the laborshed of Solano County as of the end of 2014:

Alameda: 70,305;

Contra Costa: 44,425;

• Sonoma: 22,028;

Marin: 15,253; and

Napa: 6,877.

The consideration here is that there are a large number of businesses in the other regional counties and a large number of both targets for attraction (and also competition) for Solano County residents as potential workers. The linkages among the databases gives value to these business lists:

- The QCEW (ES 202) reports tell a quarterly story, albeit with a 9-month lag, about employment, wages and number of payroll businesses in traded sectors across all counties;
- The commute data adds to the data concerning laborshed, and defines/ monitors where the most competition lies for Solano County residents and imported labor;
- The business lists define the types of employers, firms and potential competition by name, location and contact information.

Data can be tracked by city or zip code across all counties, which then can be matched up to commuting data for workforce. This provides city-level and unincorporated county business locations and counts to compare against business license data or other data. These data do not show the commuting workers, but can be set up.

### **Key Takeaways:**

  - The annual publishing of the new list will trigger a need to update the master list in the CRM tool and then ask the cities and the county for any additional information to verify and to complete the update;
- These lists allow Solano County to monitor economic diversity in terms of NAICS codes of individual businesses more completely (though there is a time lag generally of 18 months) versus the quarterly census of employment and wages (QCEW) or ES 202 reports from the Bureau of Labor Statistics/ EDD;
- The lag time is something that Solano EDC can bridge by quarterly updates to the data and to its monitoring of regional developments;
  - a. One method would be to ask the cities and the county for their license data quarterly and also use any updates to the ES 202 files as a second way to monitor change by NAICS code.

While there are local business lists available (business licenses are the main way that Solano EDC can track local businesses), even those lists have their flaws in lack of comprehensiveness, coding, and being more local than regional.

These EDD lists have the strong characteristic of being generated from the same place every year and for the same purpose: to identify payroll businesses and those that pay some payroll tax as a way of tracking business counts.

### **Using Business Lists**

The main use of business lists if to communicate with existing traded sector businesses and for business retention/expansion calls. Knowing the businesses that are in Solano County is a key data point if those businesses are to be retained. Further, it also provides a way to see the breadth and depth of businesses that are in Solano County now and describe multiple supply chains.

Identifying and monitoring the supply chains of each "traded sector" should be incorporated into planning for economic development and growth. The supply chains can be defined for each traded sector by NAICS code. The cluster analysis parallels to these lists define the supply chains and the lists monitor names and locations and contact info as part of the BREA activities of the Solano ED Task Force.

The combination of business lists and economic data about specific industries helps Solano EDC plan for change and build a strategy to identify and assist businesses that are facing concerns of growth or space.

### **RECOMMENDATIONS: USING THESE LISTS AS A BREA TOOL**

The Solano County business list delivered should be used as base for uploading and populating the BREA software. The Cities may also upload their lists that can be cross-checked.

The regional lists (other counties) should be maintained to annually track regional shifts in traded sectors, indicators of growth in those sectors and may also be competing for Solano County labor.

Lists provide a base for identifying specific businesses, rather than simply using the ES 202 (QCEW) reports and business counts, and maintaining contact information for these businesses.

Lists provide a way to populate mapping software as to the location of Solano County businesses throughout the county, separated into traded and locally-serving sectors, as well as supply chain links for traded sectors and businesses.
