If you'd like to become a member, please contact me prior to the event.

Additionally, all vendors must complete the attached Transient Permit Form. Farmers who sell their own produce and non-profit organizations are exempt from payment but still must complete the form. **The Transient Permit fee for all for-profit businesses is \$10.00, payable to the Hollidaysburg Borough.**

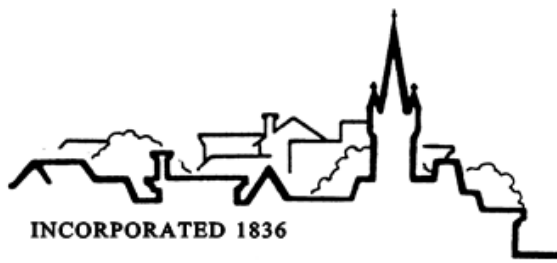
