Rules and Regulations

1. Competitions are governed by the rules and regulations of the SOBHD and ScotDance Canada.
2. Competition committee reserves the right to split, combine, or delete classes at closing date.
3. It is the responsibility of parent or guardian to ensure the competitor is entered in the correct class. Failure to do so may result in disqualification.
4. The competitor's age is taken as of Feb. 9, 2019.
5. Competitors dance in inverse order of entry.
6. Competitors must be on hand when their event is called or forfeit the entry in that event.
7. There will be no entry fee refunds without medical note.
8. All dancers must present SOBHD cards and be in costume to receive awards. Dancers will be fined \$5.00 if the mandatory SOBHD card is not provided at the time of check-in. Any related awards will be withheld until the card is presented to the Competition Secretary.
9. Status changes must be received by 8 pm, February 4th, 2019. crkehler@hotmail.com
10. Judges' decision is final. No one other than the competition committee shall communicate with the judge.
11. Protests must be made in writing, signed and given to the competition secretary before the end of the competition with a \$20.00 fee. The fee is refundable if the protest is sustained.
12. Premier Dancers in the 16 & over classes receive cash awards: 1st - \$40, 2nd - \$35, 3rd - \$30, 4th - \$25, 5th - \$20, 6th - \$15. Medals may be purchased @ \$2.00 each.
