ARTICLE V
FINAL PROVISIONS

RULE 1. *Integration of the Architectural Profession*. - The IAPOA is the existing accredited national organization of registered architects, duly accredited by the Commission and registered with the Securities and Exchange Commission as a non-profit, non-stock corporation governed by by-laws providing for a democratic election of its officers.

RULE 1.a. An architect duly registered with the PRC shall automatically become a member of the IAPOA and shall receive the benefits and privileges provided for and described in its by-laws upon payment of required fees and dues. The IAPOA shall keep an updated official registry of its bonafide members indicating membership and annual dues official receipt number.

RULE 1.b. Bona fide members of the IAPOA practicing the architectural profession shall be required to provide their official IAPOA membership number and receipt number together with their PRC registration number and professional tax receipt (PTR) on official documents prepared by them for purposes of obtaining governmental regulatory permits and licenses.

RULE 1.c. The functions, duties and responsibilities of the IAPOA shall be the following:

- a) Nominations to the vacancy of positions to the BOA;
- b) Responsibility of preparing a program of CPD;
- c) To endorse practice of foreign nationals to be issued temporary/special permit;
- d) To recommend compliance with liability insurance under a temporary/special permit, and
- e) Some other functions, duties and responsibility as may be prescribed by the BOA from time to time.

RULE 2. *Applicability of the "Rules and Regulations Governing the Regulation and Practice of Professionals"*. - In the enforcement, implementation, and administration of the provisions of R.A. 9266 and the herein "The New Rules and Regulations of the Board of Architecture", the Rules and Regulations Governing the Regulation and Practice of Professionals shall be suppletorily applicable thereto.

RULE 3. *Examination, Registration, License Fees and Fines*. - The Commission Accounting Division, out of the ten (10%) percent collected examination fees from the examinees shall provide and keep book of account for a trust fund that will defray the establishment and maintenance of the Center for continuing education and research; and out of the fifty percent (50%) collected as registration and license fees, and fines, shall provide and keep a separate book of account for a special fund for the supervisory and regulatory functions of the Board.

RULE 4. *Separability Clause*. - If, for any reason, any section or provision of the herein "Rules and Regulations" or application of such rules and regulations or provision to any person or circumstance is declared unconstitutional, unlawful or invalid, no other section or provision of this "Rules and Regulations" shall be affected thereby.
