**Intending purchasers are requested to register pre-sale at the Auctioneers Office, and will be issued with a purchaser bidding number.**

**(On production of a proof of identity, ie. Passport, Driving Licence, Recent Utility Bill)**

**Purchases can only be made with a registration number.**

**All lots will be sold in pounds (£) and a 5% (plus VAT) buyers premium will be added to all purchaser accounts.**

**IT IS IMPORTANT THAT THESE CONDITIONS OF SALE SHOULD BE READ BY  
BOTH VENDORS & PURCHASERS**

ALL LOTS MUST BE PAID FOR ON DAY OF SALE AND NO WARRANTIES WILL BE ENFORCEABLE UNTIL  
SUCH TIME AS THE AUCTIONEERS HOLD THE FULL PURCHASE MONEY AS STAKE-HOLDERS.

**CONDITIONS OF SALE**

1. The Purchaser shall be the highest bidder. In the event of a dispute between two or more bidders as to which is the Purchaser, the Auctioneer shall either declare the Purchaser, or, at his option immediately re-offer the disputed lot for sale.
2. **Commission** – The Vendor will pay the Auctioneer a commission of 5% + VAT with a minimum commission of £5 + VAT per head.
3. The Auctioneer reserves the right:
  - (i) To refuse any bidding
  - (ii) To determine the amount to be advanced at each bidding
  - (iii) To sell without reserve, unless written instructions to the contrary are received by the Auctioneer conducting the sale in question before the advertised time of sale.
4. The Vendor reserves the right to bid through the Auctioneer as his agent as often as he shall think fit.
5. Each lot shall be at the risk and cost of the Vendor until the fall of the hammer, when it shall be at the risk and cost of the Purchaser.
6. **The Purchaser shall:**
  - (i) Immediately on the fall of the hammer if so required by the Auctioneer, state his name and place of abode, in default whereof the Auctioneer may at his opinion re-offer the lot for sale and the defaulting Purchaser shall be liable to the Vendor for any loss thereby caused.
  - (ii) Pay the balance of the purchase money by **5pm** on the day of sale, in default whereof the Auctioneer may as the agent of the Vendor annul the sale and the Purchaser shall be liable to the Vendor for the loss occasioned by such default and to the Auctioneer for his commission upon the sale thus nullified.
7. No lot may be removed without a written order of the Auctioneer, which order may be withheld from the purchaser in respect of Lots not fully paid for.
8. Nothing in the above conditions shall disentitle the owner or the Auctioneer, as his agent from compelling a Purchaser to pay the price of any lot purchased by him.
9. Cheques will not be accepted in payment of Accounts without satisfactory references.
10. The Purchaser shall pay the Auctioneer a buyer's premium of 5% & V.A.T. on each lot.
11. **\*\*Vendors shall supply each lot with a serviceable halter, or at the discretion of the Auctioneer, pay for a serviceable halter supplied by the Auctioneers.**
12. The descriptions of the lots are believed to be correct but neither the Vendor nor the Auctioneers make or give, nor has any person in the employment of the Auctioneers any authority to make or give any representation or Warranty in relation to any Lot, and all statements contained in the catalogue or given at the sale as to the authenticity, attribution, genuineness, origin, authorship, date, age, period, condition or quality of any Lot are statements of opinion, and are not to be taken as, or as implying statements of representation of fact. Intending purchasers must satisfy themselves by inspection or otherwise as to all such matters, and also as the physical condition of any Lot.
13. If any Purchaser shall fail to comply with the above Conditions or any of them, the Auctioneers shall be at liberty to recover in full the amount of the purchase money of the Lot or Lots bought by such purchaser together with 10% interest and all costs, charges and expenses, without reference to any delivery or acceptance of the Lot or Lots other than the first delivery at the fall of the hammer and the declaration of acceptance as before stipulated, or to re-sell any Lot or Lots bought by such purchaser either by public or private sale, and the full amount of the purchase money at the present sale, or the deficiency (if any) arising from the second sale together with all interest charges and expenses shall be made good by the defaulter at the present sale, and be recoverable as and for liquidated damages.
14. Neither the Vendor nor the Auctioneers shall be responsible for any loss, damage, or injury, occasioned to or sustained by any person on the premises before, during or after the sale, how-so-ever the same may arise.
15. Should any question arise not provided for in Conditions the decision of the Auctioneers shall be final from which there is no appeal.
16. Vendors should check the descriptions of their lots upon receipt of the catalogue and notify the Auctioneer of any discrepancy, confirming same prior to the commencement of sale.
17. No Vendor may bid for any of his own lots except through the Auctioneers. The Auctioneers reserve the right to charge full commission on the reserve price of any lots so bought in.
18. Vendors will be charged full commission upon the sale of any lot returned for breach of condition, description of warranty or otherwise in accordance with the Award of any Arbitrator appointed under the conditions of sale.
19. All private sales made of the day of sale must be booked through the Auctioneers Office.
20. In case of dispute as to the meaning of any description or warranty, the decision of the Auctioneers shall be final and binding on all parties.
21. All animals, with the exception of foals at foot, must be led whilst in the sale ring.
22. **Any person riding an animal must wear a hard riding hat of an approved standard.**
23. No animals under 3 years of age shall be ridden or driven.
24. No animals over the age of twenty years will be accepted for sale.

- 25 The Vendor of any animal coughing at the Sale may be asked to remove the lot immediately.
- 26 It is essential that all related faults / unsoundness and vices should be declared by the Vendor including the fact that a lot has suffered from Sweet Itch.
- 27 Breeding Mares / Fillies must be either to the knowledge of the Vendor capable of breeding naturally without surgical intervention, or that any such surgical intervention to be declared by the Vendor.
- 28 **All Geldings must have the appropriate passport (PRINTED AS GELDINGS)**
- 29 WP&CS Passports must accompany all animals to the Sale. The Auctioneers will be responsible for collecting the Passports and will be handed over to all purchasers upon payment day of sale. It will be the purchaser's responsibility to complete the Passport transfer directly with the WP&CS,
- 30 **Inspectors will be operating on the morning of sale, and if any entry is found unsuitable for sale, the Vendors will be asked to remove the entry from the Sale yard.**
- 31 All complaints on any lot purchased must be logged with the Auctioneers by 5pm on the Monday following the sale day
- 32 **HORSES £300 OR UNDER WILL BE SOLD AS SEEN WITHOUT WARRANTY.**
- 33 A £20 minimum upset price will operate on all entries in the sale.
- 34 All horses offered for sale by the Auctioneers are subject to the following:

#### **Warranties**

- (a) Soundness – All lots are sold as Veterinary correct for the description in the catalogue. Lots must be free from contagious disease and of any substance capable of affecting performance or soundness. No guarantees are given or implied as to physical defects e.g., splints, curbs, side bones etc, unless they cause the horse to be lame at the time of examination, or patent conditions that are unsightly e.g. scars, blemishes providing they do not affect the health or usefulness of the horse.
- (b) Descriptions – All lots will be sold with the following Warranties only, any further catalogue descriptions is opinion of the Vendor only and for general information only.
- 1 Unbroken – must be quiet to lead and to halter
  - 2 Partly Broken – must be capable of being ridden by a capable rider in an enclosed school
  - 3 Green – must be capable of being ridden by a competent rider at slow paces in open country
  - 4 Quiet to Ride – must be quiet and easy to mount and ride away, quiet and easily managed at all paces on grass, quiet and mannerly with all traffic on the road
  - 5 Hunter – as Para 4 but quiet with hounds – capable of jumping a Novice Country
  - 6 Jumper – must be able to jump a course commensurate with described capability when ridden by an expert
  - 7 Potential – where described as “having potential” for a specific purpose, the horse must have the physical capabilities to undertake this discipline and must be examined as such by the Veterinary Surgeon
  - 8 Driving Horses – comparative guarantees as for Riding Horses under Para 2,3 and 4
  - 9 Ponies under 15hh – guaranteed as for Horses but must be easily manageable by a child of average competence and age appropriate to the size of the pony
  - 10 All lots shall be guaranteed free from Vice, Quiet in Stable, with the Blacksmith and to load in a purpose constructed lorry or trailer and quiet with the Veterinary Surgeons so as to permit full and thorough Veterinary examinations. The Auctioneers will not accept qualified variance of the descriptions or warranties above mentioned
  - 11 Vendors are warned that the following and all cognate faults must be disclosed upon their application to the Auctioneers to sell namely rib-biting, wind-sucking, weaving, box walking, sarcoids and sarcoid like lesions and whether the horse has been tubed, fired, unnerved or operated upon for unsoundness of any other kind.

1. All statements made in the catalogue must be on the entire responsibility of the Vendor, **who must before entering stock for sale, be a member of the Society.**
2. No entry for Registered Ponies will be accepted unless attached to the Entry is either:
  - (a) A copy of the Passport, or an undertaking that the application for such a certificate has been lodged with the Society.
  - (b) If eligible for registration at a further date, the correct application form for such registration completed in every particular with signatures of owner/breeder.
3. No guarantee is implied or given that any is barren or in foal. Service dates are given in good faith but are not a guarantee as to the mare being in foal. No mare or filly shall be described as “Covered” in the catalogue unless a signed “Service Certificate” is attached to the Entry Form.
4. Animals described as Colts or Stallions four years and upwards, shall be licensed as on the day of sale under the terms of the “Horse Breeding Act 1948”, or issued with a Veterinary Certificate under the Society's Scheme. No guarantee is given to Colt Foals or Yearling Colts.
5. The Auctioneers shall be responsible for the collection of all Passports for ponies sold.

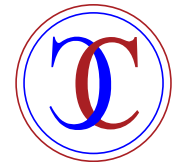
