



NOFA-NH Farm Share Program (Subsidized CSA)

Information Sheet

1. Program Objective

The objective of the NOFA-NH Farm Share Program is to provide subsidized CSA shares for limited income individuals, families, and seniors through member farms that are certified organic and have an established community-supported agriculture (CSA) program.

2. Eligibility and Requirements

A. Farm Eligibility

Farms wishing to participate in the NOFA-NH Farm Share program must be certified organic for livestock and/or crops, must be a member farm of NOFA-NH, and must have an existing CSA as part of their operations.

B. Farm Responsibilities and Requirements

Farms selected as grant recipients shall:

- Choose appropriate CSA share recipient(s) based on personal knowledge or through local or regional referrals (e.g. local food pantry, church, etc).
- Submit information to NOFA-NH regarding the chosen CSA recipient(s) along with description of CSA share type and amount of subsidy provided
 - Farm name
 - Recipient name, town, household size, senior citizens?
 - CSA share type (meat, crop, full, half, etc) and dollar amount of subsidy provided
- Provide normal communications with CSA recipient as with all of the other farm CSA members (newsletters, emails, etc)

3. Program Funding and Duration

A. Funding Availability

There is \$4,500 in the 2017 funding cycle. Awards no less than \$200 and no greater than \$800 will be considered. Program administrators reserve the right to offer funding to selected applicants at an amount less than requested in the application budget.

B. Program Duration

This program ends December 31, 2017. All reporting information must be submitted by December 31, 2017. It is hoped that NOFA-NH will be able to offer this program in subsequent years.

C. Timeframe: Grant Award Funding Decisions and Allocations

PROCESS	TIME FRAME
1. Application is available.	March 31, 2017
2. Applications are due.	April 30, 2017
3. Application review process. Applicants may be contacted for additional information to clarify the application.	May 1-9, 2017
4. All Applicants are notified of funding decision.	May 15, 2017
5. Farm chooses its CSA recipient(s) from their community.	June 1, 2017
6. Farm submits recipient information and CSA information to NOFA-NH on provided form.	June 15, 2017
7. Project ends and farm submits brief survey regarding program to NOFA-NH.	December 31, 2017

4. Application Procedure

Application Form must be completed and signed by applicant or (or authorized representative for farm). Application may be submitted digitally or by hardcopy in the mail. **Applications must be postmarked or emailed by April 30, 2017.**
