### Introduction

- NSSFF was established in April 2012 as a pilot using the London Olympic Games as the backdrop. Its mission is to increase the awareness of the importance of education in Nigeria. It is a platform, for alumni branches of Nigerian Secondary Schools based in the U.K (or associations with Nigerian connection), to showcase important work being done
- In June 2014, NSSFF held its first Education seminar in London. The day was well attended with over 75 delegates from 15 schools and guests. Member schools had the chance to showcase the work they were doing with their schools back in Nigeria.
- Princess Deun Adedoyin-Solarin chaired the occasion.
  Distinguished speakers included Cllr Adedamola Aminu.
- The keynote address was titled **Developing a set of working principles for educational development in Nigeria.**
- Participants deliberated passionately on the "Education Needs of the Next Generation of Nigerians".
- Delegates had the opportunity of using a 5 year road implementation map to outline actions needed to improve Education in Nigeria
- The event was also streamed live to a global audience.

- Teach our students how to comprehend the interconnectedness of environmental, financial, social, and other systems, and understand how the relative balance of power between societies and cultures has significant short-and long-term consequences?
- Work in partnership in order to better inform policy development, implementation and evaluation.
- Set up 'Centres of Excellence' in some of our schools in order to support one another and critically interrogate and share good practice. Establishing a Professional Learning Community amongst groups of schools thereby establishing sustainable models of professional development within and across schools.
- Partnering with Parents and students, missions, school governors, governments, unions, tertiary institutions, business community, subject associations, charities, and others to help change an educational system for the better, and not just individual institutions.

- The Nigerian education system requires a combination of state, private schools, charitable, corporate and religious organisations/institutions to provide a range of educational opportunities to Nigerian citizens.
- A significant number of state schools are understaffed due to low state budgets, lack of decent infrastructure, lack of incentives and irregularities in payment of staff salaries unlike most private (independent) schools.
- Some state-owned secondary schools are regarded as elite colleges because of the historically high educational standard and producing alumni who may have prominent citizens in various careers and subsequently provide financial support to these schools.
- I hope it is widely agreed that education is the most effective means that society possesses for confronting the challenges of the future. I would argue that progress in Nigeria increasingly depends upon the products of educated minds through a plural range (panacea) of education providers including private schools set up by corporate business.

# The Role of Diaspora in Support of Education in Nigeria?



Today with a growing population of over 168 million, the obligations of Educational institutions, responsible for providing welfare ,education &training for the next generation of Nigerians should be a primary consideration.

Access to free education is not guaranteed despite the 2005 Act . Clear and basic information in many public and private education institutions is not freely available despite Nigeria having extensive legislation at Federal and State levels. Confirmation of the quality that the Educational institution provides is not easily determined or guaranteed. Apart from exam results , standards of deliverance, provision and testing of equipment and training, has no prescribed uniform legal standard across Nigeria and is only checked through registration with the administrative bodies and infrequent inspections..

### Proposals on the way forward:

a). Review of legislation b). Uniform application of standards of education at primary secondary and vocational institutions and across Nigeria at State level c). Investment in training and resources d). Accountability and sanctions against failing states and institutions e. Inspections and reporting to be carried out frequently

### Advocacy for and on behalf of Nigeria

Nigerians living in the Diaspora can act as role models. Some of us who occupy strategic positions in educational or political establishment can also be useful and effective advocates for Nigeria. Through building partnerships with key stakeholders and lobbying as well as incisive research on topical Nigerian issues especially on education policies, formation of Diaspora "think tanks" can play a crucial role in influencing the policy debate in our host countries on a range of issues of interest to Nigeria.

### **Expanding Educational Opportunities**

Government need to enable professionals from the Diaspora that wish to participate in the expansion of education in Nigeria to do so, such as joint private investment / ownership of schools including supporting efforts by the host countries. To promote distance Learning, Diaspora institutions with access to technology would be encouraged to collaborate in distance learning programs with Nigerian partners.

### **Finally**

Diaspora has a unique window of opportunity to contribute to the economic, social and political development of Nigeria. The challenge is to take advantage of these opportunities. The Diaspora needs to be proactive, effective and organized in order to make a difference.
