Specifically, the examiner has misinterpreted the specimens as including the words "Extension Course" with the mark "THE WAY TO HAPPINESS". If the examining attorney will look again at the specimens, she will see that THE WAY TO HAPPINESS appears twice on the cover of the course pack--once in the title along with the generic term "Extension Course" and once on the cover of a booklet that is depicted on the cover of the course pack. The booklets (a copy of which is submitted herewith, without any verification) uses the mark in the same way that it appears on the cover of the course pack, but without the generic term "Extension Course."

Most importantly, in both of these uses, the mark consists solely of the words "THE WAY TO HAPPINESS." The generic term "Extension Course" merely identifies the subject matter of the particular goods marked, and is not part of the trademark for the goods. Certainly, it would have to be disclaimed as to descriptive matter if it were part of the mark, but this is not the case. The mere fact that it is displayed in a type style that is decorative, resembling part of the type style of the mark, does not dictate that it is to be considered as part of the mark.


