JUDGING SCHEDULE: All Rings start at 8:30 AM. The Judging Schedule will be available online at www.matchentries.com and <http://www.mddtc.org/club-events> after October 8, 2018.

CHECK IN PROCESS: Regular Entries ... Check in at your rings(s) upon arrival. Armbands will be at rings. Entries will be judged in armband order. Please be ready at ringside or tell the Stewards if you have a conflict. Late and Day-of-Match Entries ... Check in with the Match Secretary.

RULES: This is a sanctioned AKC Match. Exhibitors must abide by AKC Match Rules and Regulations. Corrections are limited to verbal or gently guiding the dog. Physical corrections are not allowed. Collars must comply with AKC regulations. No prong or electric collars allowed on the grounds. Toys and food are permitted, but no dropping of food in the rings. No refunds for dogs that do not exhibit. No refunds after closing date.

SITE INFORMATION: Held on the level grass of the Baseball field. Bathrooms available. Close parking. No vendors. No Shade. No staking allowed. Consider bringing chairs, alternate shade and stability. Grass may be wet in morning. Please help us keep the grounds clean.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged, I (we) agree to hold the AKC, the MDDTC, their members, directors, governors, officers, agents, superintendents or event secretary and the City of Clayton, its officers, employees and volunteers and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. I (we) agree that any cause of action, controversy or claim arising out of or related to the entry, exhibition or attendance at the event between the AKC and MDDTC and myself or as to the construction, interpretation and effect of this agreement shall be settled by arbitration pursuant to the applicable rules of the American Arbitration Association. However, prior to arbitration all applicable AKC bylaws, rules, regulations and procedures must first be followed as set forth in the AKC Charter and Bylaws, rules, regulations, published policies and guidelines.
