RESOLUTION NO. 4977-2005

ADOPTING REPUBLIC ACT NUMBER 9266, OTHERWISE KNOWN AS 'THE ARCHITECTURE ACT OF 2004.'

WHEREAS, the Twelfth Congress in its Third Regular Session, enacted Republic Act No. 9266, entitled "AN ACT PROVIDING FOR A MORE RESPONSIVE AND COMPREHENSIVE REGULATION FOR THE REGISTRATION, LICENSING AND PRACTICE OF ARCHITECTURE, REPEALING FOR THE PURPOSE REPUBLIC ACT NO. 545, AS AMENDED, OTHERWISE KNOWN AS 'AN ACT TO REGULATE THE PRACTICE OF ARCHITECTURE IN THE PHILIPPINES,' AND FOR OTHER PURPOSES";

WHEREAS, Republic Act No. 9266, otherwise known as "The Architecture Act of 2004," is fully supportive of the policy of the state recognizing the importance of architects in nation building and development;
