RESOLUTION NO. 2005-012

RESOLUTION ENJOINING THE HONORABLE MAYOR ROSENDO R. CORALES TO EFFECT THE IMMEDIATE IMPLEMENTATION OF THE REPUBLIC ACT 9266 KNOWN AS THE "ARCHITECTURE ACT OF 2004" AND ITS IMPLEMENTING RULES AND REGULATIONS

*WHEREAS*, Republic Act No. 9266, An act providing for a more responsive and comprehensive regulation for the registration, licensing and practice of Architecture, repealing for the purpose Republic Act No. 545, as amended, otherwise known as "An act to regulate the practice of Architecture in the Philippines", and for other purposes was approved by Her Excellency President Gloria Macapagal-Arroyo on March 17, 2004;

*WHEREAS*, the Implementing Rules and Regulations (IRR) of Republic Act No. 9266 was approved by the Board of Architecture on September 15, 2004;

*WHEREAS*, Section 4 of IRR of R.A. 9266 state that the effectivity of the Act shall be after fifteen (15) days following its full and complete publication in the Official Gazette or in two (2) major newspapers of general circulation;

*WHEREAS*, the IRR of Architecture Act of 2004 was fully and completely published in the Official Gazette on November 15, 2004;

WHEREAS, the United Architects of the Philippines (UAP), San Pablo City Chapter requested the help of the Sangguniang Bayan of Nagcarlan for the immediate implementation of R.A. 9266;

WHEREAS, Section 444,(2),(iii) states that the Municipal Mayor shall

(2) Enforce all laws and ordinances relative to the governance of the municipality x x x x x and in the foregoing shall;

(iii) Issue such executive orders as are necessary for the proper enforcement and execution of laws and ordinances.

NOW THEREFORE, on motion of Hon. Councilor Ariel P. Coronado as seconded by the members of the Ad-hoc Committee and approved by the all members present do hereby:

RESOLVED as it is hereby resolved, to enjoin the Honorable Mayor Rosendo R. Corales to effect the immediate implementation of the Republic Act No. 9266, known as the "Architecture Act of 2004" and its Implementing Rules and Regulations.


RESOLVED FURTHER that a copy of the R.A. 9266 and the publication of its IRR in the Official Gazette be made an integral part of this resolution.
