DURING FISCAL YEAR 2016 (JULY 2015), PARTICIPATING STUDENTS RODE APPROXIMATELY 400 MILES OVER 7 DAYS WHILE VISITING AND STAYING AT 7 COLLEGES: SYRACUSE, CORNELL, BINGHAMTON, SUNY ONEONTA, SUNY COBLESKILL, BARD AND WEST POINT. THE PROGRAM IS DESIGNED TO EXPOSE OUR STUDENTS TO, AND EDUCATE THEM ABOUT, THE COLLEGE APPLICATION AND FINANCIAL AID PROCESS, WHILE CREATING A CONNECTION IN THEIR MINDS BETWEEN UNDERTAKING AND ACHIEVING THE PHYSICAL CHALLENGE OF THE TOUR WITH SETTING AND ACCOMPLISHING THE GOAL OF APPLYING TO AND ATTENDING COLLEGE.

ALL NINE SENIORS OF THE JULY 2015 COLLEGE BIKE TOUR GRADUATED HIGH SCHOOL IN JUNE 2016, EIGHT ARE CURRENTLY ENROLLED IN COLLEGE AND ONE ENLISTED IN THE US NAVY. ONE STUDENT ENROLLED AT SUNY COBLESKILL AS A DIRECT RESULT OF VISITING THE COLLEGE DURING THE TOUR.



