On September 15, 2016, Concord Crossroads, LLC was awarded its second GSA Schedule Contract on the newly established Professional Services Schedule [00CORP]. More commonly known as the GSA Schedules, the General Services Administration's Multiple Award Schedule [MAS] Program, was developed to assist federal employees in purchasing products and services. The long-term indefinite delivery, indefinite quantity [IDIQ] contracts contain pre-negotiated prices, delivery terms, warranties, and other terms and conditions which streamline the buying process. As part of GSA's work to improve the Multiple Awards Schedule Program and usability of its Schedules, GSA established a single Schedule contract solely for 4,400 professional services across eight schedules, renamed Professional Services Schedule [00CORP]. Beginning in 2015, this initiative allowed Federal agencies to procure complete solutions for commercial professional service requirements and positioned GSA to continue to improve the quality and pricing of its contracts. Under the newly established Schedule, C3R has been awarded two SINs. Within SIN 874-1 Integrated Consulting Services, C3R will provide expert advice and assistance in support of a government agency's missionoriented business function including management, strategic consulting, research, evaluation, studies, analyses, simulations, reports, business policy and regulation assistance, and strategy formulation. As for the second awarded SIN 874-7, Integrated Business Program Support Services, C3R shall provide services to assist government agencies in managing their mission-oriented business projects or programs and achieving mission performance goals. This newly awarded contract allows C3R to provide existing customers with more comprehensive options when seeking opportunities for us to provide continued excellent service.
