## NORTH CAROLINA REGIONAL COUNCILS OF GOVERNMENTS

Regional councils in North Carolina are the result of 1969 legislation that charged the Department of Administration with developing "...a system of multi-county regional planning districts to cover the entire state" (GS143-341) after Congress passed the Intergovernmental Cooperation Act in 1968 calling for closer cooperation between federal programs and state and local governments.

By 1970, an Executive Order had designated 17 regions in North Carolina. In 1971, the state announced its Lead Regional Organization Policy that directed state agencies to deal with a single regional organization in each designated region of the state for the delivery of services in several departments.

Regional Councils have been operating in the state since 1972 although many were organized long before the official state designation (WPCOG was organized in 1968). In July 2011, Regions G and H merged into one region (Piedmont Triad Regional Council), bringing the total regional councils to 16.

Regional councils provide a wide variety of programs and services to their local governments and residents. The nature and extent of the programs vary greatly, depending on local needs and priorities.

The NC Association of Regional Councils of Governments is staffed by Executive Director Betty Huskins and David Huskins, who serves as Legislative Liaison.
