WHEREAS, the International Association of Official Human Rights Agencies (IAOHRA) is a professional association of over 140 state, county, and local human relations commissions in the United States of America and several statutory human rights agencies in Canada that has as its purpose and jurisdiction the elimination of discrimination; and,

WHEREAS, our nation is founded on the principles of "one person, one vote" and government by the consent of the governed; and

WHEREAS, the Fourteenth Amendment to the U.S. Constitution provide all citizens of the United States of America with the guarantee of the equal protection of the laws, and gives Congress the power to enforce this guarantee; and

WHEREAS, over 500,000 people living in the District of Columbia, the capital of our democratic nation, are denied Congressional Representatives in the U.S. Senate and only one representative in the U.S. House of Representatives with no voting powers; and

WHEREAS, the District of Columbia residents share all the responsibilities of American citizenship, including the payment of over \$3 billion annually in federal income taxes, but are denied

equal civil rights with their fellow Americans living in the states; and

WHEREAS, the Inter-American Commission on Human Rights of the Organization of American States has found the United States to be in violation of international human rights law for its disenfranchisement of District of Columbia residents; and

WHEREAS, there are serious efforts in many states to reenfranchise non-citizen immigrants permitting them voting rights in national, state and local elections.

THEREFORE, BE IT RESOLVED that IAOHRA supports full voting representation for the residents of the District of Columbia by supporting Congresswoman Eleanor Holmes Norton and Senator Joseph Lieberman's "No Taxation without Representation Act" (H.R. 398 and S. 195) and similar solutions for full voting representation of District of Columbia residents.

BE IT FURTHER RESOLVED, that the delegates of the 58th Annual Conference encourages bipartisan support in the U.S. House of Representatives and U.S. Senate for the "No Taxation Without Representation Act" and encourage IAOHRA members to contact their representative and ask them to be a co-sponsor of this legislation.

HURRICANE KATRINA AND RITA

PURPOSE: JOIN THE NAACP AND OTHER CIVIL RIGHTS **GROUPS ADVOCATING FOR FULL AND PROPER COMPENSATION FOR GULF COAST RESIDENTS**

PARTICULARLY IN THE UNDERSERVED.

WHEREAS, the International Association of Official Human Rights Agencies (IAOHRA) is a professional association of over 140 state, county, and local human relations commissions in the United States of America and several statutory human rights agencies in Canada that has as its purpose and jurisdiction the elimination of discrimination; and,

WHEREAS, in the aftermath of Katrina and Rita's arrival billions Of dollars of damage were dealt to New Orleans, Louisiana, Gulfport and Biloxi, Mississippi, Mobile County, Alabama and the Gulf Coast Regions; and

WHEREAS, over a quarter of a million people were displaced due to Katrina and Rita's wrath: and

WHEREAS, due to a failure to plan by various agencies within the United States Government, many of the Gulf Coast minorities and poor were left in disparate, unforgiving environments; for as long as 7 days; and

WHEREAS, local and state officials in the region made multiple requests for federal assistance, including military personnel, all of which were not answered within a timely manner; and

WHEREAS, due to a failure of planning and execution of natural disaster policies and procedure, many of the Gulf Coast's poor and minorities did not receive any federal assistance for evacuation or shelter until almost two days after Hurricane Katrina hit the Gulf Coast: and

WHEREAS, the approximate death toll in the wake of Hurricane Katrina has risen to over 1,200 people making this Hurricane on of the deadliest as well as costliest in US history; and

WHEREAS, the United States Congress has passed legislation appropriating funds for the Hurricane Katrina relief; while also passing legislation that has relaxed hiring procedures that secure fair and just employment practices and also relaxing federal contracting standards to level the playing field for bidding on federal contracts; leaving minorities businesses, with little chance to participate in the devastated Gulf Coast economy and workers with little wage; and

WHEREAS, thousands of the Gulf Coast displaced persons have sought shelter and residence throughout America and are seeking federal assistance from FEMA and other government agencies, to return them to being productive ad active US citizens; now

THEREFORE, BE IT RESOLVED, that IAOHRA urges the United States President and Congress to ensure that all people living in America, in every area that is prone to floods, earthquakes, hurricanes, tornadoes, or any other catastrophic event are made aware of what to do in any and all emergency situations; and

BE IT FURTHER RESOLVED, that IAOHRA work for the fair wages and contracts on behalf of minority business owners and workers; and

BE IT FURTHER RESOLVED, that the IAOHRA will diligently work for full and proper compensation and health-related assistance for minority business owners and residents of color displaced form the Gulf Coast by Hurricanes Katrina and Rita; and

BE IT FURTHER RESOLVED, that IAOHRA calls for a declaration of urgency in the recovery efforts to restore all underserved citizens affected by Hurricane Katrina and Rita so that rules can be waived or temporarily altered in order to:

- 1. fairly compensate such citizens for losses;
- 2. rapidly certify small businesses that wish to become eligible for government contracts (all levels);
- 3. expeditiously process loans for minority businesses;
- 4. facilitate prompt acquisition of loans and mortgages to African Americans;

- 5. waive payment for existing student loans;
- 6. expand eligibility for educational grants, low interest loans and work study programs;

BE IT FURTHER RESOLVED, that the delegates of the 58th Annual Conference urge the U.S. Senate the House of Representatives to call for a declaration of urgency for full Compensation for Hurricane Katrina and Rita victims.

WHEREAS, the International Association of Official Human Rights Agencies (IAOHRA) is a professional association of over 140 state, county, and local human relations commissions in the United States of America and several statutory human rights agencies in Canada that has as its purpose and jurisdiction the elimination of discrimination; and,

WHEREAS, on August 29, 2005 the worst natural disaster in the history of the United States devastated the State of Louisiana and the Gulf Coast region in the form of Hurricane Katrina; and,

WHEREAS, thereafter, Hurricane Rita compounded the suffering and extended the damages experienced by the people in the Gulf Coast region; and

WHEREAS, the destruction of the faulty levee system was not able to provide adequate protection and led to the decimation of both commercial and residential property, loss of life and displacement of over 900,000 people; and,

WHEREAS, the federal government promised to rebuild Louisiana and the Gulf Coast region; and,

WHEREAS, 329 members of the House of Representatives and 45 U.S. Senators have not traveled to the Gulf Coast to view the aftermath of Hurricane Katrina's devastation; and,

WHEREAS, thousands who survived Hurricane Katrina and Hurricane Rita are still displaced and continue to suffer one year after these catastrophic events; and need to rebuild their

communities in all areas, including, but not limited to, housing, education, healthcare and employment; and,

WHEREAS, there are non-binding, but morally authoritative "Guiding Principles" on internal displacement that include state obligations to protect people from disaster and to provide for their needs as well as for the right to return;

THEREFORE BE IT RESOLVED, that the delegates of the 58th IAOHRA Conference urge and strongly recommend that U.S. Congressional members visit the area devastated by the disasters of Hurricane Katrina and Hurricane Rita in order to assist them in understanding the necessity to fully fund the rebuilding of Louisiana and the Gulf Coast region; and,

BE IT FURHTER RESOLVED, that the delegates of the 58th IAOHRA Conference ask Congress to support, without delay, House Bill 4761 entitled "Domestic Energy Production Through Offshore Exploration and Equitable Treatment of State Holdings Act of 2006" to provide a steady stream of funding for the Gulf Coast region from offshore oil and gas revenues for coastal restoration, protection and production.
