





**TITLE:** MINORITY BUSINESS PARTICIPATION IN  
GOVERNMENT CONTRACTS

**PURPOSE:** TO ENCOURAGE MINORITY BUSINESS  
PARTICIPATION IN GOVERNMENT  
CONTRACTS

**WHEREAS,** the International Association of Official Human Rights Agencies (IAOHRA) is a professional association of over 140 state, county, and local human relations commissions in the United States of America and several statutory human rights agencies in Canada that has as its purpose and jurisdiction the elimination of discrimination; and,

**WHEREAS,** many states no longer adhere to minority business goals on State funded public works projects, resulting in dramatic decrease in the number of African American businesses participating in government contracts; and,

**WHEREAS,** the voters of several states have authorized abolition of goals and programs for minority owned business using state tax payers funds on public works projects that were established through legislation and public law; and,

**WHEREAS,** the Black Chamber of Commerce, during testimony before Congress in September 2007, noted the failure of the Small Business Administration to provide needed technical assistance to minority owned businesses; and,

**WHEREAS,** the Black Chamber of Commerce during testimony before Congress in September 2007, stated that minority owned businesses have been decimated in recent years because of their inability to secure government contracts and subcontracts; and,

Minority Business Participation in Government Contracts

**WHEREAS**, in testimony before Congress, in September 2007, the Black Chamber of Commerce stated that there was less than 0.02% participation by African American contractors in FEMA contracts during the Katrina recovery; and,

**WHEREAS**, natural disasters that are declared disasters by the President and/or state governors impact the lives of individuals of all races, colors, genders, ages and ethnicities and persons with disabilities equally and recovery responsibilities should be shared similarly among all contracts awarded equitably now;

**THEREFORE BE IT FINALLY RESOLVED**, that IAOHRA call upon Congress, the Small Business Administration (SBA), the Office of Federal Procurement Policy and all federal, state and local agencies to: 1) promote the use of minority business enterprises in the participation of federal, state and local contracts and subcontracts; 2) provide more oversight and monitoring of contracts for compliance in using minority business enterprises and other small and disadvantaged businesses; 3) call for the enforcement of existing laws and penalties on agencies and prime contractors that fail to comply; and 4) that the federal government be precluded from suspending these requirements based upon urgent need circumstances.

**PURPOSE: TO COMMEND THE HONORABLE DAMON J. KEITH FOR 40 YEARS ON THE BENCH**

**WHEREAS**, the International Association of Official Human Rights Agencies (IAOHRA) is a professional association of over 140 state, county, and local human relations commission in the United States of America and several statutory human rights agencies in Canada that has as its purpose and jurisdiction the elimination of discrimination; and,

**WHEREAS**, Judge Damon J. Keith, who sits on the U.S. Court of Appeals in Detroit, Michigan marked 40 years on the bench in September 2007 and the longest serving African-American judge in the federal judiciary; and

**WHEREAS**, President Lyndon B. Johnson appointed Judge Keith the U.S. District Court in Detroit and in 1977 President Jimmy Carter appointed him to the U.S. Court of Appeals for the Sixth Circuit; and

**WHEREAS**, as a member of the federal judiciary, Judge Keith has consistently been a courageous defender of the constitutional and civil rights of all people; and

**WHEREAS**, over the course of the 40 years, Judge Keith has ruled on several significant cases; and



**WHEREAS**, Judge Keith's best known decision, *United States v. Sinclair*, is referred to as the *Keith Decision*. The Supreme Court unanimously affirmed Judge Keith's decision in that case, which prohibited President Nixon and the federal government from engaging in warrantless wiretapping because it was in violation of the Fourth Amendment; and


**WHEREAS**, in the aftermath of 9/11 in *Detroit Free Press v. Ashcroft*, Judge Keith ruled it unlawful for the Bush Administration to selectively conduct secret deportation hearings.

**WHEREAS**, Judge Keith has received numerous honors and recognitions for his service to the judiciary; and

**WHEREAS**, as a community leader Judge Keith organized local businessmen to provide housing for the late Rosa Parks after she was robbed and physically assaulted in her house and was responsible for organizing members of the African American business community in time to save the Charles H. Wright Museum of African-American History from bankruptcy; and

**WHEREAS**, Judge Keith is committed to develop and mentor aspiring lawyers and judges and

**THEREFORE, BE IT RESOLVED** the International Association of Official Human Rights Agencies commends the Honorable Damon J. Keith for his outstanding service to the citizens of the Sixth District and the United States of America.







**WHEREAS**, on November 7, 1960, the "Arthur Report" recommended enforceable fair employment legislation for Kansas; and,


