

Rules of Assessment of English Proficiency for Eligibility to Graduate from Department of Entertainment Management of I-Shou University

- I. Implementation Basis: The Guidelines are enacted pursuant to the Implementation Guidelines on Assessment of Students' Overall Capability for Eligibility to Graduate from I-Shou University.
- II. Purpose: The Guidelines are made in order to improve students' English proficiency and assist students' career planning and employment.
- III. Class: The Guidelines are applicable to day-time students (include transfer students) of 2010 academic year and thereafter.

V. Implementation Methods:

1. Students, except for having taken all required courses, shall demonstrate Students' Overall Capability for the said Assessment Standards.
2. Students who have passed Assessment Standards to Graduate shall submit application form and standardized testing report to Department of International Tourism and Hospitality for evaluating qualification requirements within two weeks before the end of each semester. Once the evaluation is approved, the zero-credit course "English Proficiency" will be registered as "Assessment Passed." Students who pass the Graduation Qualification Assessment and Operation Standards are not required to register such course.
3. ITH department approve various types of English Proficiency Test based on the B2 level of "Common European Framework of Reference: Learning, Teaching, Assessment (CEF)" which is recognized by the Ministry of Ministry of Education. The tests include: GEPT, TOEFL, TOEIC, IELTS, NETPAW, CSEPT, FLPT, Cam. Main Suite, BULATS, and GET.

VI. Substitute Measures for Failure to Pass the Assessment Test: Students

who fail to pass the English Proficiency Assessment Test may take English Ability course offered to seniors and juniors by Department of International Tourism and Hospitality or General Education Center in winter or summer as a substitute. The tuition of English Ability is the same as that of summer courses. Once the course is successfully passed, the grade of English Ability will be registered as “PASSED”. Students can get 50% subsidy for the tuition if they took one Assessment Test every academic year, for more than three times. The subsidize limited only once.

VII. The Guidelines are subject to approval of College Affairs Council Meeting, and shall come into effect after being adopted by on the day of promulgation by the President. Amendments must also undergo the same procedure.

一、實施依據：本作業規定依本校「學生基本能力畢業資格檢定實施辦法」訂定之。

二、實施目的：配合教育部國際化之政策並提升本系學生英語能力，以強化學生升學及就業競爭力，特訂定本作業規定。

三、實施對象：自 98 學年度(含)以後入學之大學部學士班學生(含轉學生)。

四、英語能力檢定標準：

五、實施方式：

- (一)學生於修業年限內，除修滿本系規定應修學分外，學生「英語能力」必須達到第四點所列任一檢定標準，方具畢業資格。
- (二)已通過校外英語能力檢定者，須於大三下學期結束前將有效期限內之成績證明文件(正本)及申請表，送至系辦公室登錄，以作為該項「英語能力」檢定通過之評定依據。審核通過後，本系將該成績以「檢定通過」之方式登錄於必修零學分科目「英語能力」之課程。如以上揭檢定方式通過畢業資格檢定標準者，學生不須自行辦理該科目選課作業。
- (三)本系所認定之各語言檢定考試，係依據教育部採認之「歐洲語言學習、教學、評量共同參考架構」(CEF)之語言能力分級 B2(高階級)為基準，其測驗種類包括：「全民英檢」(GEPT)、「托福」(TOEFL)、「多益」(TOEIC)、「國際英語語言測驗」(IELTS)、「網路全民英檢」(NETPAW)、「劍橋大學英語能力認證分級測驗」(Cambridge Main Suite)及「劍橋大學國際商務英語能力測驗」(BULATS)。

六、未通過檢定考試替代措施：

學生未通過英語檢定標準者，得參加由本系或通識教育中心於寒、暑假針對大三、大四學生所開授之「英語能力」課程，其收費標準比照暑修課程。課程結束經評定成績及格者，其「英語能力」成績以「通過」登錄。學生入學後，每學年曾參加本作業規定之英語能力檢定考試一次，總次數達三次以上者，修習本課程本校補助一半學費，以一次為限。

七、本作業規定經院務會議及教務會議審議通過，陳請校長備查後自公告日實施。
