


HOW WELL DO YOU KNOW BROTHER K?

In November 2014 Brother K posted one of many solicitations for charity to fund his cross-country travel escapades. In this post he also asked for money to cover legal fees associated with his arrest in Tuscaloosa, Alabama.

Two days later, on a lark I decided to tease him by making a donation to the American Academy of Pediatrics. I chose the AAP because he often launches into rants against the medical association. (I was inspired by an activist who once sent a donation to NARAL, an abortion-rights group, "in honor" of Terry Randall, a fiery anti-abortion leader.) The online donation form provided the option to have a brief message printed on the notification card, and I playfully referred to his release from prison.

Friends, the Southeast Circumcision Protests were a remarkable success, 13 cities in 12 days, with local intactivists from all over the southeast joining us on the frontlines, and media in numerous cities covering our protests. Unfortunately, I'm returning to California tonight with a legal cloud hanging over [Bloodstained Men & Their Friends](#) in Tuscaloosa, Alabama. [Kelley Heitzman](#) and I are due in Tuscaloosa municipal court next Monday on the charges related to our Saturday protest there. Our coordinating attorney, [David J Lewellyn](#), has been working the phones with his Alabama contacts today, and we will be able to obtain legal counsel in Tuscaloosa, but not a volunteer attorney as we had hoped. The unknown costs of our legal defense will cut into our public protest budget, and may lead to the cancellation of our planned 2015 New England/Northeast protests, a two-week event that will have to be put on hold until we have clarity about the legal costs of this case. All of us are very grateful for your donations, 😊 those of you who have donated in the past, 😊 and in the last 24 hours, and those of you who intend to donate in the future. 


He misled his followers and revealed my address

Four weeks later, on December 10 Brother K received a card from the AAP notifying him that a donation had been made in his honor to the *AAP Friends of Children Fund*. He immediately took to Facebook, telling followers that a “rabid circumcision crusader” (rather than the AAP) had sent a letter (rather than a card) to his *unpublished* home address. In a comment he revealed **my** name and **my** home address on a public post, making it accessible to anyone with a Facebook account. As his action constituted a clear violation of Facebook Community Standards, Facebook removed the comment within 24 hours.




He inadvertently doxxed himself

Brother K suggested that I had “worked hard” to find his home address. Perhaps he didn’t realize that his address became a matter of public record the moment he registered his anti-circumcision group as a non-profit. It took just a couple of minutes to find him; no hard work was involved.



Hollie Ann Redinger





At one time Jeni Evison had protested alongside Brother K. She has since shed the belligerent tactics for an honest and sensitive approach. She runs a Facebook group where intactivists and Pro-Parents Choice advocates (PPCs) debate circumcision and related issues without the personal attacks and hyperbole that typically ruin online discussions.

Evison tried to reason with Brother K, who responded with an angry rant. He informed her that I was using a fake name, accused me of stalking him, and claimed that my residential address he had revealed on Facebook was the location of a mailbox service. It’s unclear whether he was trying to deceive Evison – or whether he actually believed these fictions.



His account of the AAP donation notification has become more imaginative and bizarre. He continued to call me a *nom de guerre*, and said that I stalked him and threatened to send “henchmen” to his home. He even imagined that the AAP card constituted a death threat.



Brother K has lied to you about me as recently as January, 2017

Brother K bristles when other intactivists criticize his behavior. But this hypocritical tyrant rules with an iron fist, prohibiting his followers from associating with PPCs. Observe his anger in earlier screen shots about “putative intactivists” that “cozied up to the pro-circ troll” who “plays them like a violin.”



Michelle VanGurp

In May 2015, Michelle Marie VanGurp traveled 900 miles to protest outside a medical conference. She spent a week away from her family volunteering at intactivist events in San Francisco and Berkeley.

She invited me to meet her at a protest. We ended up meeting in person one evening at a local restaurant. Accompanied by Danielle Cruzen, VanGurp debated me for 45 minutes. Before parting ways, the three of us posed for a picture that I posted in Jeni Evison’s debate group.



After the photo was shared in intactivists groups, Brother K quickly blocked both women from his Facebook account. He blocked Cruzen despite the fact that **she had graciously hosted him in her home** just days earlier. Only after Cruzen offered a groveling apology did he grant her the privilege of sending him another friend request.



Months later VanGurp discussed Brother K’s manipulative behavior.

Bro blocked me without saying a word and talked about me as though I was pro circ, after I met with **Andrew Gross** in May of last year....this was while I was protesting with BK for four days in San Francisco (mind you, I travelled for over 24 hours straight to get to this protest, and protested for 2 full days longer than BK, yet, I was branded a troll because I went outside of his box), he then, after many conversations with a friend, unblocked me and told me to request his friendship, again, so we could "get back to normal."

Bro threatened to block me if I didn't delete my group, which was a fight club for intactivists, PPC, and pro-circ folks, to battle it out about everything under the sun. He messaged every single intactivist in the group (nearly 300 of them) and told them all to leave, or else. He harassed me via messages for several days until I shut the group down.

Bro blocked me after I created the Effective Intactivism group, which was made to discuss more effective ways to spread our message, and to be better activists as a whole. Again, he messaged everyone in the group (over 150 of them) and told them to leave the group or else. He then made passive aggressive

statements about me on his page, talking about fake intactivists lurking in our groups and undermining the intactivist efforts.

I've done 4 protests with BK, and not one was close to me. I traveled 200 miles for my first one, got a hotel room for him, bought pizza and beer for him....the second was the following day, and another 200 miles away. The third was a 17 hour train trip, and 4 days away from my family. The fourth was a 27 hour train and bus trip and a week away from my family, yet he has the audacity to call me fake.

A couple of weeks ago, he unblocked me, because I commented on a thread about recent blogs denouncing intactivist methods that attack. He now follows me and watches every comment I make. He has even gone as far as to go through my Facebook, and like or put those annoying sticker comments on pictures and posts of me protesting with him in the past.....

Sexism in the Workplace: No Es...

“I hold this against the BSM and Brother K. They ignore it. They refuse to do anything.” – Savannah Hutchinson

Daniel Tati’s misogynist views have been well known. In February 2017 it was revealed that Tati is a serial sexual harasser who has used the intactivist network to locate targets. Tati frequently sent unwelcome sexual advances to dozens of married women and minors. Brother K lamented having to mediate “an unfortunate matter,” whitewashing the harassment as an inappropriate “mistake.” At first Tati claimed that a “circumfetishist” framed him. Then he announced that **he** was the victim, blamed “feminists” and “circumcision”, and refused to take responsibility. Three months later Tati continued to deny any wrongdoing. Yet Brother K was “persuaded of his sincerity.”

When Michelle VanGurp stepped outside her comfort zone, Brother K immediately ostracized her. When she launched a new group to promote intactivism, Brother K disparaged her, sabotaged her efforts, and stalked her online. Yet he defends an unrepentant misogynist – despite all the harm Tati has caused.



Edith Brooks I was defending Daniel until I saw the extent of his messages. He may not be a criminal but he's using his status as an intactivist to get access to women who otherwise wouldn't give him the time of day and he's abusing that access by sending gross and inappropriate messages. He does not belong in our community. He is not needed if he can't treat fellow activists with respect.

Who's the real-life stalker?

June 29, 2014

Brother K and two friends protested at the 2014 San Francisco Pride Parade. A 19 year-old dressed as Tinkerbell approached them and told him that she thought their anti-circumcision protest was not appropriate at a family event. When the cameraman got in her face, she put her hand up to block the camera, and he pushed her hand away.



She tried to end the confrontation by leaving the area, but Brother K refused to leave well enough alone. He and the others followed the teenager for about 50 feet. Ignoring her cries to "Leave me alone!" they surrounded her and continued to jeer. She shoved Brother K away from herself. He taunted her, "YOU ARE GOING VIRAL!" Then he turned to the cameraman and asked, "Did you get her punching me?"



Their video shows that when an onlooker dared to criticize him, Brother K eagerly provoked her. He aggravated the conflict for the sole purpose of creating a video for social media. He doesn't respect personal boundaries, and he appears ignorant or unconcerned that a petite young woman might reasonably fear for her safety when she's pursued by three hostile older men.

February 27, 2013


A nurse in Spokane, Washington, posted a status update proudly announcing the first circumcison of her nursing career to her friends on Facebook. Set to public, Sasha Ormand's post was quickly discovered and shared in intactivist groups.



Enraged by the teasing quip, Brother K drove to Spokane, Washington. With camera filming, he entered the clinic and tried to confront Ormand.

Think about that. A rational person wouldn't drive **NINE HUNDRED MILES**, enter a medical facility, and confront someone **OVER A FACEBOOK POST!** That is the behavior of a stalker.

Brother K continues to brag about these and other examples of his creepy, stalking behavior.



Warning signs that you may be in a cult

- The group displays excessive zeal and unquestioning commitment to its leader and his ideology and practices.
- Questioning, doubt, and dissent are discouraged or punished.
- The leadership dictates how members should think, act, and feel.
- The group claims a special, exalted status for itself, its leader, and members. (e.g., the group is on a special mission to save humanity.)
- The group has a polarized us-versus-them mentality, which may cause conflict with the wider society.
- The group teaches or implies that its ends justify whatever means it deems necessary. This may result in behaviors or activities that members would have considered reprehensible or unethical before they joined the group.
- The leadership induces feelings of shame and/or guilt in order to influence and/or control members. Often, this is done through peer pressure and subtle forms of persuasion.
- Members are expected to devote inordinate amounts of time to the group and group-related activities.
- Members are encouraged or required to socialize only with other group members.
- The most loyal members feel there can be no life outside the context of the group. They believe there is no other way to be, and often fear reprisals to themselves or others if they leave the group.

Brother K claims that I lied about him.

Brother K claims that I shared his address with others.

The truth is that he shared my address – to the world.

Brother K claims that I'm a stalker.

The truth is that he is an unrepentant stalker.
