As regional winners in the Health category, Whitney and Dr. Gabriel will now be considered for the national EY Entrepreneur Of The Year award, which will be announced on November 10 at the company's Strategic Growth Forum in Palm Springs, Calif.

Whitney, the chief executive officer, and Dr. Gabriel, the chief operating officer, were presented with the award at the ceremony on June 14 at the Beverly Hilton, highlighting their commitment to leading a national practice that seeks to transform radiology. In 2012, Whitney and Dr. Gabriel created Radiology Partners, a large-scale radiology practice that combines the benefits of local physician leadership and partnership with the advantages that come with scale.

Other finalists in the health category were Castulo de la Rocha, chief executive officer and president of AltaMed Health Services Corporation, and Stephen Samuel, chief executive officer of Premier Pharmacy Services.

"I can't begin to express how grateful and proud we are to have received such a distinguished award," said Dr. Gabriel. "We were in good company, with extremely talented individuals in the health industry, and congratulate these parties on being finalists. We're honored to use this award to inform more people about the exciting and innovative work we're doing at RP."

Whitney, a graduate of Harvard Business School, has spent his entire career in healthcare services, including as an investor, entrepreneur and operating executive. He was a lead executive in the financial and operating turnaround of DaVita Inc., helping create more than \$3 billion of equity value between 2000-2003. Dr. Gabriel earned his MBA from the University of California Anderson School of Management. He then joined DaVita Inc. as Vice President of Commercial Patients and eventually transitioned to Chief Information Officer.

Whitney and Dr. Gabriel met at DaVita Inc. and reunited in 2012 to start Radiology Partners with backing from New Enterprise Associates (NEA). Over the past five years, RP has emerged as a leader in the field due to its focus on groundbreaking clinical programs, and a commitment to developing great physician leaders,



fostering a culture of physician engagement and ownership. The practice has seen significant growth lately, including partnering with the largest radiology practices in [Arizona](#), [California](#), [Florida](#) and [Louisiana](#).
