We reserve the right to sell your grass space if not checked in by 8:00 a.m. on Saturday. An outdoor show, rain or shine.

**Photos:** One photo of your display, photos of the products you make and photos of you working on your products.

Photos and detailed descriptions of the products you display are accepted.

**Space Assignments**: All space assignments will be made by the Art and Craft Show Board. Exhibitors may not trade space without show director's approval.

**Share Exhibitors:** Exhibitors who wish to split the cost and share the exhibit must do so upon application. All rules apply and must be paid in full with completed application and photos.

**Purpose:** This Art and Craft Show is for the public enjoyment and the purchasing of unique artwork and crafts. We encourage working exhibitors.

## On site provisions:

- 1. All exhibits are to be handmade by the exhibitor. No commercial kits, toys, merchandise, flea market items or rummage sale items allowed. (LTD, Ohio Wholesale, Wang's, Tenderheart, bulk potpourri, Etc.)
- 2. No products from kits.
- 3. If you sell berry wreaths, bring your raw materials to demonstrate the making of the wreath from start to the finished product.
- 4. Large framed prints. NOT Allowed... unless you're the artist. Smaller prints under \$30.00 a piece will be allowed. The smaller print can be purchased by you, but the emphasis will be on the hand crafted frames. Photos of you molding process and photos of the boards will be required.
- 5. Wholesale clothing that you have stitched, embroidered or hand painted on is allowed.

- 6. NO marshmallow guns, bow & arrow sets or toy weapons.
- 7. LBPA has the right without recourse to relocate or remove any or all exhibits during the event show.
- 8. Exhibitor's parking- two blocks east of the Craft Show area (towards the Mississippi River). The RV Park is located at 8<sup>th</sup> Avenue North & Riverview Drive.
- 9. Exhibitors are required to abide by all unloading and loading procedures as stipulated in the acceptance package.
- 10. Exhibitors are required to display their merchandise until 5:00 pm on Saturday & 4:00 pm on Sunday.
- To alter or paint on something bought from different sources is NOT allowed under any circumstances. Supplementing your booth with wholesale items – NOT allowed. If you are selling wholesale or by sell items, you will be removed from the Show mailing list and from the Show.

A true artist or crafter cannot possibly compete for sales at a show, against the low priced wholesale items and we will not support anyone. We appreciate your help to make this a true Art & Craft Show.
