For use by Domestic Nonprofit Corporations**

Pursuant to the provisions of Act 162, Public Acts of 1982, the undersigned corporation executes the following Articles:

ARTICLE I

Knollwood Memorial Park Cemetery

ARTICLE II

Consistent with the General Corporation Act 327 of 1931,

Within the auspices of the Cathedral of St. Augustine's, this corporation shall operate, manage, and maintain the KMP Cemetery for ground internment and preservation of human remains, including cremation services, crematory, entombment, Columbarium, crypt, mausoleum consistent with laws and regulations that govern. As well, the corporation shall maintain Endowment, Perpetual, Merchandise Trusts consistent with laws that govern.

ARTICLE III

1. The corporation is formed upon a Non - Stock basis.


