**Entry Fee: \$50.00 (\$25.00 for Non Profit) Limit of two vehicles per single entry. Connected Vehicles like a truck and trailer or boat and trailer count as one vehicle. Bikes are not counted as vehicles but golf carts are. The additional charges for more vehicles are \$5 for each motor cycle and \$10 for each additional vehicle. The charges are to help offset the annual cost of the parade.**

**Please initial the following items in the spaces indicated:**

\_\_\_\_ Any motorized vehicle (anything with wheels and a motor) must be driven by an adult 18 years old or older with a valid driver’s license and insurance.

\_\_\_\_ Every generator used, must have a corresponding, charged and rated fire extinguisher. The float will be inspected for compliance at the staging/registration area and cannot participate without an appropriate extinguisher.

\_\_\_\_ **NO ALCOHOL** is permitted on the float, at the staging area or along the parade route.

\_\_\_\_ **ABSOLUTELY NO STOPPING.** The parade **MUST** remain moving at all times! ***The Parade will go on Rain or Shine!***

\_\_\_\_ **NO ITEMS MAY BE THROWN or HANDED OUT** along parade route.

\_\_\_\_ No **Santa Costumes allowed.** He always is on the last float only. Do not confuse the children (in all of us).

Violations will result in being removed from parade, disqualification from judging and entry in next year’s parade.

**There will be a MANDATORY parade meeting November 28th from 5:30 to 7:00PM at Bethel Creek House, (4405 Highway A1A). Parade day organizers and Float drivers should attend.**

**If representatives from your organization do not attend the meeting, your organization will not be able to participate in the parade.**
