# The priority will be delivery against the 5 strategic priorities as identified within the Business Crime Delivery Plan:

1. Work will be undertaken to reduce business related crime with greater emphasis on offender management interventions, crime prevention initiatives and working more collaboratively with businesses

- 2. Priority will be given to continuing to reduce crime and anti-social behaviour relating to:
  - The Night Time Economy (Terms of reference as below) Adapted from the City Centre Night Time Economy Steering Group. Young people will be encouraged to engage through more innovative ways.
  - The Day Time Economy (Draft terms of reference as below) Providing a
    partnership response to the business crime and anti-social behaviour that impact
    upon day time economy areas. Particular focus will be given to retail crime, cash in
    transit and commercial robberies, metal thefts, bilkings (making off without payment)
    and public place nuisance.

3. Work will continue to reduce crime and anti-social behaviour on the public transport network to increase passenger confidence and safety

4. Work will be undertaken to understand the nature and extent of emerging business threats of cybercrime and fraud, including Trading Standards violations, ensuring a dual focus on business crime and personal victimisation.

5. New relationships will be developed with businesses:

- To encourage a focus on community safety via existing forums such as our Business Improvement Districts
- To promote corporate social responsibility and encourage business participation in local community safety programmes and support the Birmingham Business Charter for Social Responsibility

#### Superintendent Rich Baker- WMP ( Chair) (BCSP Police & Crime Board Lead – TBC)

The purpose of the Night Time Economy Steering Group is to develop and oversee the implementation of the Birmingham Community Safety Partnership's Night Time Economy Delivery Plan on behalf of the Birmingham Community Safety Police and Crime Board. This Steering Group contributes towards the strategic priority – Business Related Crime.

The role of its members is to articulate the views and perspectives of their host organisation to help inform a collective approach to the development and implementation of the Delivery Plan and to take responsibility for implementing policy and practice changes within their organisation as appropriate.

The Steering Group on behalf of BCSP will:

- Oversee and co-ordinate the work of BCSP to provide a strategic perspective on the Night Time Economy
- Review progress and impact of the Night Time Economy Delivery Plan
- Deliver interventions which are cost effective and provide value for money
- Ensure a robust approach to planning for critical periods and key events
- Support the successful retention of the Purple Flag status

The Steering Group will also act as:

 Independent Advisory Group for West Midlands Police for Night Time Economy

#### Frequency:

The group will meet approx. bi-monthly to review progress against the delivery plan. There will be a larger meeting held bi-annually inviting wider partners involved in the NTE. This will be held in June for Christmas planning and January for Summer planning.

#### Accountability:

The steering group is accountable to Birmingham Community Safety Police & Crime Board for detailing progress against the priorities set out in the Night Time Economy Delivery Plan

#### **Decisions and Disputes:**

Decisions will normally be reached by consensus. In the event of a disagreement the chair of the Night Time Economy Steering Group will consult with the Head of Birmingham Community Safety Partnership to resolve outstanding issues.

#### **Conflict of Interest:**

Members are expected to declare any conflict of interest and withdraw from membership of the group discussion or decision, which compromises them.
