Child Advocacy

Whether your child has special needs, mental health or behavioral issues, and/or learning obstacles, a Child Advocate can represent your child's educational rights within a school structure, giving them the guidance and support necessary to implement change and progress in your child's academic life.

Adult Advocacy

The Alliance's Adult Advocacy services are central to obtaining government benefits and services, protecting rights, and fighting discrimination. On an individualized basis, Adult Advocates assist mental health consumers and their families in obtaining legal representation and in accessing community mental health and case management services.

The Consumer/Family Satisfaction Team (CFST)

Enhancing client satisfaction with the mental health system in our area is important to the Alliance. Berks CFST helps to ensure that consumers and families with federally-funded mental and behavioral health insurance receive quality care, timely service, and courteous treatment.

Peer Support Central

Do you or a loved one have a major mental illness (such as a mood or thought disorder) and have Medical Assistance? The Alliance proudly offers the support of Certified Peer Specialists. Based on the age-old tradition of peer mentoring, eligible individuals—referred to as “peers”—who need additional support in their mental health recovery are matched with consumers who have completed state accredited certification. By setting and meeting personal goals, peers become a model of mental illness recovery and may enjoy healthier and more productive lives.

NAMI (National Alliance on Mental Illness) Programs

NAMI outfits consumers and family members impacted by mental illness with programs that emphasize awareness, understanding, and recovery. As the Alliance grows, our availability of NAMI programs is growing, too, under the umbrella of similar core values.
