## From the Director's Desk

### The Butter Lady's Life & Legacy



As a child during the depression era Luella Ross lived in Turpentine Camp #13 in North Florida. Luella's father and mother both worked at the Turpentine Camp. Her father died when she was very young and her mother became disabled when Luella was five years old. Another woman in the camp Cora Jackson became her adopted mother. Cora was a practicing midwife who taught Luella about the home remedies and the herbal folk medicines that later in life she would come to share with many visitors to the Pioneer Settlement.

During the mid-nineteen eighties Luella came to the Pioneer Settlement through a program that provided training and jobs for older people. Luella became one of the Settlement's most valuable resources. Luella was a teacher's aide for nearly two decades and earned the nick name of "The Butter Lady" although she would also share her folk medicines and home remedies and sometimes weave or spin if that was what was needed for a field trip.

In a 2004 local newspaper interview at the age of 79, Luella reflected on her family life. Luella was married to Reverend George Washington "G.W." Ross. She was the mother of nine boys and one girl and she quit counting the "grands" after number thirteen. Luella also fostered many children in her home and adopted four of them. Her favorite movies were westerns and she liked John Wayne, her favorite song was the hymn "Father, I Stretch My Hand to Thee" and The Holy Bible was her favorite book. Even though her life was hard

at times there were the simple joys of close-knit families and she remembers "being very happy growing up and in a good home."

Luella's love for children, her admiration for Marilyn Breeze the Settlement's director during that time and her "buddy" Pedro (the farm donkey) is what kept her working at the Pioneer Settlement on into her 80's. I imagine though, that part of her dedication was fueled by a passion to pass on and share history and traditions.

The passing down of cultural traditions and the history of how and why things came to be are even more important in today's world where mediocrity is acceptable and instant gratification has become the norm. Teachings about the pioneer lifestyle are critical for future generations to develop an understanding of values like freedom and faith and to garner an appreciation for integrity, personal responsibility and a strong work ethic. Whether she realized it or not, Luella had and shared all that.

Although I never had the opportunity to meet her I'm very much in awe of her legacy, her passion for children and her love of sharing history. As woman who lived in a turpentine camp, Luella brought something that no one else could to the Pioneer Settlement. They say everyone is replaceable but I don't think that is true about Luella.

Our long-time friend and former staff member Luella Baker Ross, 93, entered the sunset of her life on Wednesday, July 18, 2018. May her friends and family be comforted with the knowledge of the many lives she touched through her work here at the Barberville Pioneer Settlement and beyond. May she rest in peace.

**We need your old Christmas Cards!** One of the lessons we do with the children during our Old Fashioned Traditions Program (when they visit England at the Cabin) is the history of the Christmas Card. This added revenue has enabled us to do a better job of grounds maintenance and upkeep of our buildings and the property.

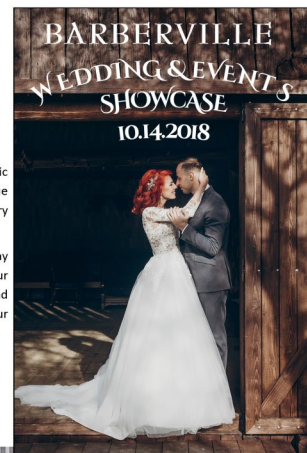

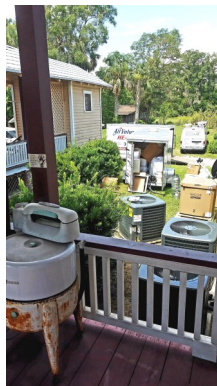


## Chairs, Curtains & Air Conditioners – Oh MY!

Over the last few years our fundraising campaigns have consisted of acquiring new Chairs, Curtains & now Air Conditioners. Providing a safe and comfortable atmosphere for you and your children while visiting the Settlement is a top priority for us. Having efficient and worry free climate control in our main building is part of that. So are the curtains and the chairs.

The day they told us that the compressor was shot in one of our 17 year-old 8 seer air conditioners was somewhat of a blessing in disguise.

We are very grateful that our Board approved the expenditure to replace all five of the units at the same time. As we welcome our newest cooling and heating additions we have also acquired an expense that although we knew was coming didn't expect for this year. Thanks to great credit and little debt we were able to acquire a loan and are anxious to pay it off as soon as possible. **All Volusia & Flagler Heating and Air** was chosen from the seven bidding contractors by the Board to provide the new heat pump units. It was very much appreciated that they donated back to us \$1,000.00.



You probably remember in the summer of 2015 we launched our *Crappy Chair Campaign*. We keep the majority of the 84 chairs (that your donations made possible) in storage to be used for special events like weddings and we do not use them outside. Currently we have \$149.00 in the chair campaign and we continue to keep the crappy chair set-up in our school hallway because people love it and we still want to buy about 20 more chairs.

*The Shabby but not so Chic Curtains Campaign* began the summer of 2017 with the goal of raising \$3,500.00 to purchase blackout shades, curtains and hardware for the 14 windows in the high school auditorium. Thanks to you, gracious givers, we raised \$5,050.00 and have installed blackout shades in all of the 14 auditorium windows as well as 6 in the inside kitchen and 6 in our administrative library/meeting room. We saved money by opting to make our own curtain rods and repurposing some curtains as valances. Our goal now is to expand the campaign to eventually cover thirty more windows! Thanks to our

friend Mike Arminio at **Bay Breeze Blinds** for helping us out with this project. The blinds are MADE in the USA – Orlando to be exact.

As of now we have \$880.00 in this campaign.

Our new Air Conditioners Campaign that we just launched the end of June has raised \$1,525.00 already through our Facebook page post. We are very thankful to those of you who have contributed. We are not setting a goal for this campaign as we are just looking for help towards paying off our new loan.

Some might say that Pioneers and Seminoles didn't have air conditioning, blackout shades and cushioned chairs. To them we say we are grateful that we do! We have had visitors and staff experience heat related health issues here on occasion and I can't imagine not having a comfortable place to take them to cool down. We owe all of what we do and what we have to the generosity of our donors.

Between the new blackout shades and the new air conditioning you will notice a difference on your next visit to the Settlement. While you are here take an extra moment to sit and relax and soak up the air in our 100 year old Schoolhouse! Feel the cool, cool air (or the heat if its wintertime) and know that we are very thankful to you.

These envelopes were printed last year so the A/C Campaign is not listed as a choice and you will have to write it in. 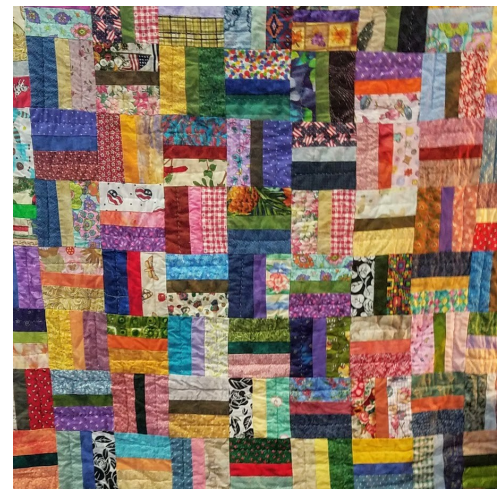
