TERMS & CONDITIONS

- Entrants must be aged between 18 and 30 years of age. Exhibiting artists must be no younger than 18 years of age nor older than 30 years of age on the 10 November 2019.
- 2. Entrants may submit up to two artworks for judging in the following media: painting, drawing and or printmaking.
- 3. Dimensions must not exceed 1200 x 1800mm including the frame. Works weighing in excess of 10kg will not be accepted.
- 4. All entries must be ready for hanging, either framed with large D-rings attached to the back of the works and works on canvas/board must also have large D-rings attached. Unframed works on paper will not be accepted.
- 5. Work must be the original work of the artist, not previously shown in the Lane Cove Municipality and completed in the last two years.
- 6. Application forms and entries must be accompanied by a fee of \$35.00 (one artwork) or \$70.00 (two artworks) (GST included) which covers handling and administration, plus Jpeg images no later than Sunday 10th November 2019. Entries postmarked prior to this date but arriving after the closing date will be accepted.
- 7. Entries submitted for the award must be delivered as indicated in the diary and the exhibitor is responsible for all forward and return freight costs.
- 8. The work must be clearly labelled on the back with the artist's name, address, telephone number, title, medium and price.
- The artist is deemed to have accepted sole responsibility for ensuring that the work submitted by the artist does not infringe any relevant copyright laws.

- 10. The organisers reserve the right to have any work reproduced in the press or on television or internet for promotional purposes. Further, the organisers reserve the right to have the winning work reproduced in full colour. Copyright claims for these purposes only, will be deemed to be waived by the artist when the work is submitted for judging.
- 11. Artist must supply ABN number or a "Statement by Supplier" with their entry form or 48.5% will be withheld from their payment of sales. If you require advice on this matter please call the Australian Taxation Office on 132 478.
- 12. Centrehouse shall retain 27.5% plus GST commission on the sale of work.
- 13. Every care shall be exercised but the organisers shall be in no way responsible for any damage, loss or theft. Artists are responsible for their own insurance cover against damage, loss or theft.
- 14. All unsold works shall be collected from Gallery Lane Cove on Monday 20th January between the hours of 9.30am and 5.30pm.
- 15. No work selected for inclusion in the exhibition shall be removed from the exhibition prior to the closing date: 18 January 2020.
- 16. The winning artwork will be acquired for the Lloyd Rees Memorial Youth Art Award Collection, Lane Cove Council.
- 17. All attempt will be made to accommodate entrants work (that meets with the conditions of entry) however, the judges reserve the right to select works for the final hanging in the instance of insufficient hanging space. The judges' decision shall be final and no correspondence will be entered into.
- 18. The organising committee will dispose of works not collected by the 25th January 2020 at their own discretion.
- 19. The organisers reserve the right to reject any work that does not meet the specified criteria outlined in points 1–11 inclusive.
