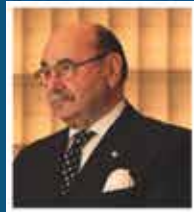

Ambassador Raúl A. Estrada-Oyuela



Ambassador Raúl A. Estrada-Oyuela has been called the ‘Father of the Kyoto Protocol’ in recognition of his pivotal role while chairing the negotiations that resulted in adoption of that landmark climate treaty. A lawyer by profession, the Argentinian has held several high-ranking posts during his long career as diplomat and negotiator. Aside from his leadership in the climate negotiations, he served as the Argentinian Ambassador to China and Ambassador-at-large for Environmental Negotiations, and has taught at the law schools at Stanford and Columbia University. He lives in Buenos Aires.

A selection committee of leading climate law scholars, chaired by Ambassador Estrada-Oyuela, will evaluate the substantive quality, originality and clarity of submissions. The five best entrants will be published in CCLR Issue 2/2017. The overall winner will receive a €1.000 award, a one-year subscription to the Carbon & Climate Law Review and a certificate signed by Ambassador Estrada-Oyuela in his capacity as patron of the award.

Submissions should address an issue related to climate change and the law. Entrants can freely choose the sectoral and geographic focus of their submissions, but should try to provide insight into how the law as a social institution and normative framework can promote or impede our response to climate change. Both legal and interdisciplinary methodologies are welcome. Only submissions in English will be considered.

Participation Requirements:

- Thematic focus on climate change and the law
- Undergraduate, graduate or doctoral student status (or graduation no earlier than 1 April 2016)
- Format: 5.000-7.000 words, in English, using style guideline available at: www.lexxion.eu/cclr/author-guidelines
- Deadline for submissions: 15 March 2017
