
Agreement on deposits of aircraft

This AGREEMENT ON DEPOSITS OF AIRCRAFT ("Deposit Agreement") is effective from the date of agreement

The key conditions in this Deposit Agreement are:

Aircraft: Jupiter J4S

Purchase Price: 189,000 € Estimated + Additional Options

Deposit amount: 1000 €

Return: Yes

Account: Yes

Position number: [for Jupiter assignment]

Having considered and taking into account the mutual conditions set forth herein and other useful and valuable information, the receipt of which is recognized, Jupiter and the Buyer (each "Party" and collectively "Parties") entered into an agreement:

Section 1 PRICE OF PURCHASE AND REFUNDS

Section 1.1. The approximate price can be changed at Jupiter's sole discretion. The base price of the aircraft includes a set of basic options and equipment specified in the Appendix to the Sale and Purchase Agreement. The final purchase price for Jupiter J4S aircraft will be formed and approved after the selection of additional equipment or services, and will be specified in the Agreement on the Purchase of Aircraft.

Section 1.2. The deposit is held on a holding account, currently in Network International Bank. Jupiter is responsible for the costs of the holding account and is entitled to any interest earned on deposited funds. The bank can be changed by ICON at its discretion. The buyer agrees to provide information that may be requested by the bank agent. The bank agent executes Jupiter's written instructions regarding the deposited funds. The bank agent has the right to accept instructions from Jupiter in the following cases:

- If the Buyer cancels this Deposit Agreement. In accordance with its terms, Jupiter will send an instruction on the return of the Deposit to the Buyer.
- If the Buyer signs the Aircraft Purchase Agreement, Jupiter will send an instruction to transfer the Deposit to Jupiter. The Deposit amount will apply to the Purchase price of the aircraft, as provided for in the Aircraft Purchase Agreement.
- If the Buyer can not timely cancel or conclude the Aircraft Purchase Agreement, Jupiter will send an instruction to transfer the Deposit to Jupiter. The deposit will not become the property of Jupiter if the Buyer does not enter into a Sales Agreement or does not cancel or do not perform the Aircraft Purchase Agreement as provided for under this Deposit Agreement.

Section 1.3. The buyer can cancel this Deposit Agreement by sending a written notice to Jupiter not later than twenty-one (21) calendar days from the date of the production notice (as defined in the Conditions). In the event that the Buyer timely cancels this Deposit Agreement, the Buyer's Deposit will be refunded less than 500 € one-time commission.

Jupiter will return the Deposit to the Buyer within forty five (45) days after receipt of the notice of timely cancellation by refunding the Credit Card used for the Deposit.

Section 1.4 Jupiter will use this Deposit Agreement as an important indicator of demand for aircraft and will accordingly take into account development and production costs. If this Deposit Agreement is terminated by Jupiter, the Buyer shall be notified in writing of the reasons for the cancellation. Jupiter returns the Deposit to the Buyer within forty five (45) days after sending the notice by refunding the Credit Card used for the Deposit.

Section 2 COMMUNICATION

Section 2.1 After the implementation of this Deposit Agreement, the Buyer will receive an e-mail from Jupiter confirming receipt of funds, the number of the item in the queue, the approximate date of commencement of production, and the conclusion of the Purchase and Sale Agreement.

The buyer is responsible for providing the correct contact information for Jupiter at any time. Jupiter will use the Buyer's contact information as the primary way to contact the Buyer.

Section 2.2 Any notice to the Purchaser under this Deposit Agreement may be sent by e-mail or by any other means.

Each notice is considered received at the time of actual receipt and within 48 hours a response to the notification from Jupiter has been generated.

Section 3 TOTAL AGREEMENT

Section 3.1. This Deposit Agreement forms all agreements between the parties and supersedes all prior written or oral arrangements regarding its subject matter. The buyer pays the Deposit by filling out the form of payment. This Deposit Agreement becomes mandatory when accepting Jupiter, which must be executed by sending an e-mail to the Buyer confirming receipt of the Deposit and an e-mail indicating the number of the delivery item (the date of acceptance, "Effective Date").

The buyer acknowledges that the Buyer has read, understands and accepts this Deposit Agreement in full.
