Dear Chairman Burgess and Ranking Member Green,

On behalf of the 41 undersigned organizations representing the Nursing Community Coalition, we would like to thank you for including the Addiction Treatment Access Improvement Act of 2017 (H.R. 3692) in the opioid package the Energy and Commerce Committee is considering. The members of the Nursing Community Coalition are the cross section of education, practice, research, and regulation within the nursing profession and fully support the goal of this legislation to help curb the opioid epidemic. With over four million licensed Registered Nurses (RNs), Advanced Practice Registered Nurses (APRNs), and nursing students, the profession embodies the drive and passion to continually improve care for patients, families and communities. The coalition is committed to improving the health of our nation and we believe H.R. 3692 helps to achieve this end by providing a permanent solution so that all APRNs may prescribe Medication Assisted Treatment.

Broadening the Controlled Substances Act (21 U.S.C. 823 (g)(2)(G)) to include all four APRN roles will greatly expand access to patients suffering from opioid addictions. Opioid use and dependence are growing public health threats, despite the many actions put in place to try to curb this crisis. APRNs are critical agents in treating patients that experience these crises, and are sometimes the sole providers of this care in regions that struggle to recruit and retain providers. The Addiction Treatment Access Improvement Act of 2017 creates a permanent solution so that nurse practitioners, clinical nurse specialists, certified registered nurse anesthetists, and certified nurse-midwives are able to use their clinical training to help combat this national crisis.

Again, we would like to express our strong support of H.R. 3692, and would like to see its inclusion within the final version of the opioid package.
