

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.HelpingKidsAchieve.com and Cindy Terebush, Early Childhood Consultant and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Cindy Terebush, Early Childhood Consultant include www.HelpingKidsAchieve.com. Collection of your Personal Information
