- If you are in the city you'll need a business license. The Business License ordinance can be found on the City of Easley website, www. cityofeasley.com. Call the Business License official Keith Kennedy, 864-855-7900, ext. 7207 or email at Kkennedy@cityofeasley.com to find out your rate classification. Easley uses standard NAICS codes and the standard SC Municipal Association model business license ordinance.
- Restaurants pay a 2 percent monthly hospitality tax, due on the 20th of each month. Reporting forms are available on the city's website, www.cityofeasley.com.
- If you will be using an existing building, you'll need a fire inspection before you open for business. Call Fire Marshall Brad Owen, 864.859.8950 for an appointment.
- If you plan to build, you'll need to contact the Planning and Development Office and the City's Building Official located on the lower level of City Hall at 205 N. 1st Street. The Easley Building Official is Tommy Holcombe. He can be reached at 854.855.7900, ext. 7402 or email at tholcombe@cityofeasley.com. He handles permits and inspections. Your general contractor and all sub-contractors must have a business license.
- Signs for your business must be approved by the Building Official. All exterior alterations (including paint) to existing buildings, as well as new construction or

- additions, must have the Building Officials approval. Submit a sign application (available on the website) with a \$25 check to cover the permit fee. All zoning related questions may be referred to Tommy Holcombe.
