



Santa Bárbara Mission Archive-Library Photocopy Policies

All photocopying requests of documents, manuscripts, and books will be subject to the following policies and guidelines.

- The charges for photocopies are \$.75 (\$.50 for members) per page for standard size (8 ½ x 11) and \$1.25 (\$1.00 for members) per page for larger sizes. Any requests exceeding 10 pages of material will be assessed a service fee of \$40.00 an hour (\$35 for members), with a one hour minimum. Extensive requests may require a deposit before photocopying will begin. Postage is an additional charge.
- Requests will be completed and delivered once payment is received.
- We reserve the right to deny requests for photocopying because of fragility, poor image, size of item, or other circumstantial problems related to a specific work or collection.
- The photocopies are intended for personal research purposes only. Providing photocopies does not imply permission to publish the items. Requests for reproduction for publication must be filed separately. Please refer to the Reproduction of Manuscripts, Art Works, and Photographs Policies.
- We do not allow photocopying of photographs. Photocopying of published material is limited to ten percent (10%) of the entire work.
- We do not allow individuals to take digital photographs of documents, manuscripts, books, or art work. Digital reproductions must be requested separately. Please refer to Reproduction Conditions.
- Reproduction is permitted only from photographic material supplied by the Santa Bárbara Mission Archive-Library. Reproduction from printed or other non-photographic material not supplied by the SBMAL is strictly prohibited. Items will not be lent to individuals for copying.

Santa Bárbara Mission Archive-Library Digital Reproduction Fees

The Santa Bárbara Mission Archive-Library fees for the reproduction of a work of art or photograph are as follows:

- Digital Scan, First image \$45. Each additional image for same request \$35

- Requests will be completed and delivered once payment is received.
- We reserve the right to deny requests because of fragility, poor image, size of item, or other circumstantial problems related to a specific work or collection.
- The digital images are intended for personal research purposes only. Providing these images does not imply permission to publish the items.
- Requests for reproduction for publication must be filed separately. Please refer to the Reproduction of Manuscripts, Documents, Art Works, and Photographs Policies.
- For information regarding permission for publication and use fees for each image for commercial and non-commercial purposes please contact the SBMAL at director@sbmal.org or by phone at (805) 682-4713 ext. 152.
- Extensive photo searches will be charged \$35 an hour (\$25 for members). To request the reproduction of a work of Art or photograph in the Santa Bárbara Mission Archive-Library, an application must be submitted.

Santa Bárbara Mission Archive-Library Conditions of Permission for Reproduction and Use of Art and Photo Images

- Reproduction is permitted only from photographic material supplied by the Santa Bárbara Mission Archive-Library. Reproduction from printed or other non-photographic material not supplied by the SBMAL is strictly prohibited. Items will not be loaned to individuals for copying.
- Permission is granted for one time usage, in one publication, and one edition only. Usage for revised or new editions will be considered after another application.
- Full documentation and ownership credit, as specified by the SBMAL, must appear either directly under the reproduction, on the page facing, on the reverse, or in the illustration credit section. Full documentation consists of the artist's name, title of the work of art, date, and the institution's name, "Santa Bárbara Mission Archive-Library". In addition to SBMAL, the credit line must include the donor's name when indicated.
- In the case of books with reproductions bound within the text: if the Archive-Library's reproductions would be the only ones in this publication giving this full information in one of the above state locations, then you may list only the artist's name, title of the work of art, and the date. Complete documentation must appear elsewhere within the book, such as in an index or list of illustrations.
- In the case of films, videos, cds, dvd, or filmstrips: if it is not stated on the adjacent frame, this information must appear in the accompanying manual.
- If an object is not entirely reproduced, that is, if it is cropped in any way, the caption must include the word "detail." The work of art is to be reproduced without "bleeding," alteration, or overprinting of any kind.
- Immediately after publication, one copy of the publication shall be sent to the SBMAL.

- The permission hereby granted terminates immediately upon publication. No images obtained by permission of the SBMAL may be copied or resold or shared in any way, nor deposited in a library or collection (other than the applicant's personal files) without first obtaining specific authorization from the SBMAL.
- A use fee will be billed on the order invoice.
- The SBMAL reserves the right to refuse to copy art works because of fragility, poor image, size of item, or other circumstantial problems related to a specific work or collection.

Santa Bárbara Mission Archive-Library Conditions of Permission for Reproduction and Use of Manuscripts

- Reproduction is permitted only from photographic material supplied by the Santa Bárbara Mission Archive-Library. Reproduction from printed or other non-photographic material not supplied by the SBMAL is strictly prohibited. Items will not be loaned to individuals for copying.
- Permission is granted for one time usage, in one publication, one edition only, and one printing. Usage for revised or new edition(s) or reprints will be considered after another application.
- Full documentation and ownership credit as the Santa Bárbara Mission Archive-Library must appear with the reproduced document or in the acknowledgments and/or credits where appropriate.
- Immediately after publication, one copy of the publication shall be sent to the SBMAL.
- The permission hereby granted terminates immediately upon publication. No images obtained by permission of the SBMAL may be copied or resold or shared in any way, nor deposited in a library or collection (other than the applicant's personal files) without first obtaining specific authorization from the SBMAL.
- A use fee will be billed on the order invoice.
