Disaster Recovery - During 2015, NECHAMA provided assistance to 75 households recovering from Hurricane Sandy throughout the Greater New York Region. In addition to providing direct, voluntary repair services for those who were most vulnerable, NECHAMA worked with funders to provide additional resources such as building materials and appliances. NECHAMA also provided direct repair assistance to 6 households in the Gulf Coast region, still struggling to recovery from Hurricane Katrina 10 years after the storm.

Disaster Response - In 2015, NECHAMA assisted over 150 families throughout Massachusetts, Michigan, Minnesota, South Carolina, and Texas to clean up after tornadoes, straight-line winds, floods, and blizzards. We led volunteers to clear away debris and damaged possessions, demolish unsafe structures, muck out flooded homes, remove downed and damaged trees, shovel pathways through snow, and clear roofs of snow accumulation and ice dams. Priority was given to those unable to do the work themselves or who otherwise fall into a vulnerable population category.

Disaster Preparedness - During 2015, NECHAMA provided free disaster training related to cleanup, chainsaw operation and safety, repair work, and volunteer management to over 35 individual volunteers. We also worked with a municipality to develop a disaster response plan should a natural disaster occur in the future. We participated in Voluntary Organizations Active in Disaster at both the national and state levels, extending our expertise to the broader disaster community.
