

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Amendments to the Charter of the Tohono O'odham Community College 11
Tohono O'odham Code Chapter 1)

RESOLUTION NO. 18-199

1 **WHEREAS,** the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2 the authority to "promote, protect and provide for public health, peace, morals,
3 education and general welfare of the Tohono O'odham Nation and its members"
4 and to "authorize, charter and regulate public or private corporations and
5 associations whether organized for profit, or for non-profit or charitable
6 purposes" (Constitution, Article VI, Section 1(c)(2) and Section 1(e)); and

7 **WHEREAS,** the Charter of the Tohono O'odham Community College, Ordinance No. 98-01,
8 was approved by the Legislative Council and adopted on January 13, 1998; and

9 **WHEREAS,** the Tohono O'odham Community College and Human Resources Development
10 Committee collaborated to draft amendments to the Charter dated for reference
11 2018, and which are incorporated by this reference; and

12 **WHEREAS,** the 2018 amendments to the Charter reflect the current structure of the College,
13 eliminate unnecessarily detailed job descriptions, elaborate on the duties of the
14 Board of Trustees, and require that at least two of the Board of Trustees be
15 recognized O'odham elders; and

16 **WHEREAS,** the Human Resources Development Committee recommends adopting the 2018
17 amendments to the Charter of the Tohono O'odham Community College in the
18 best interests of the Nation's members.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council adopts the
20 2018 amendments to the Charter of the Tohono O'odham Community College.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH
22 day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-
23 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
24 Article VI, Section 1(c)(2) and Section 1(e) of the Constitution of the Tohono O'odham Nation,
25 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
26 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
27 Act of June 18, 1934 (48 Stat.984).
