#### Licensed Home Health Agencies (HHAs)

Governing Body - The California Department of Public Health (CDPH) (http://www.cdph.ca.gov).

**Governing Law** – Division 2, Chapter 8 of the California Health and Safety Code (sections 1725-1742). All HHAs are licensed by the state, and their employees are licensed and/ or certified by their respective professional supervisory organizations.

Services (Medical and non-medical, up to 24 hours)

- Skilled nursing (RNs, LVNs)
- Therapy (Physical, Speech, and Occupational Therapists)
- Social work (Social Workers, LCSWs)
- Nutritional guidance (Dieticians)
- Custodial care (Home Health Aides)

Some Home Health Agencies provide care on both a shift and visit basis, while others offer only visits.

### Medicare Certified Home Health Agencies \*

Medicare Certified Home Health Agencies have met all the Federal standards required for providing care to Medicare clients and accept Medicare payment. Medicare clients must be homebound and require a skilled medical need under physicians' orders.

Medicare Certified HHAs generally provide care on a visit basis rather than with long shifts.

#### Licensed Home Care Organizations (HCOs)

Governing Body - The California Department of Social Services (CDSS) (http://www.cdss.ca.gov/cdssweb).

**Governing Law** - The Home Care Services Consumer Protection Act of 2015 (HCSCPA). All HCO Home Care Aide (HCA) employees are required to be state registered. The CDSS maintains and continuously updates this public registry. Consumers have access to this registry to verify HCA registration.

Services (Non-medical, up to 24 hours a day)

- Custodial care
- Companionship
- Personal care
- Homemaking

#### **Licensed Hospice Agencies**

Governing Body - The California Department of Public Health (CDPH) (http://www.cdph.ca.gov)

Governing Law – The California Hospice Licensure Act of 1990 (California Health and Safety Code sections 1745-1759).

Services (Medical and non-medical, usually visit-only)

- Comfort care (pain and symptom management)
- Emotional and spiritual support

Hospice agencies provide care and support for an individual facing a life-limiting illness and their family. Their services are paid for by Medicare, MEDI-CAL, and most private insurers.

### Why Is Licensing Important?

Licensing protects consumers by reducing the risk of abuse, neglect, fraud, or inadequate care. Licensed providers are subject to regulatory oversight by the State of California.

### The Benefits of Using a Licensed Agency

Licensed agencies...

- ...are required to employ trained, licensed, and state registered staff.
- ...have experienced caregivers ready to work on short notice if schedules change or a previous caregiver becomes unavailable.
- ...assume full liability for all care.
- ...assume responsibility for: o Employee hiring and oversight.
- o Employee taxes, insurance, and benefits.
- o Developing and updating a plan of care.
- o Background and reference checks, as well as all state licensure requirements including TB tests and fingerprint submission to the Department of Justice.
- o Continuing education and ongoing skill training for caregivers.
- o Supervision and oversight.
- Long Term Care and Workers Comp insurance accepted
