## GENERAL RULES

### Show Theme: *“Celebrate Winter Holidays Around the World”*

**Show Colors:** Gold, Silver, Red and Green

**Show Hours:** Monday, November 5, 2018 6 p.m. to 9 p.m.  
Tuesday, November 6, 2018 9 a.m. to 4 p.m.

This Flower Show conforms to the standards established by National Garden Clubs, Inc. The *Handbook for Flower Shows* (HB) 2017 Edition, with revisions printed in the *National Gardener* magazine, is the authority for all issues not covered by the Schedule, which is the Law of the Show.

**Eligibility:** Any adult member or friend of WSFGC may enter any class or sub-class in Division I, Horticulture; Division II, Design; Division III, Education; Division IV, Botanic Arts. Advance entries are required in Division I Section J, Division II, III and IV. All entries are to be the work of one exhibitor, except for Educational Exhibits.

**Advance Entries:** All entries in Division II and Division III, must be made with the Advance Entries Chairmen by October 15, 2018, only one entry per class or sub-class. Only Division I, Horticulture Section J needs to pre-register. **Exhibitor must provide a substitute if unable to participate.**

**Entry Tags:** Horticulture entry tags will be available from District Directors after October 1, 2018 or on the WSFGC website. All other tags will be completed by the Advance Entry Chairmen and the Entry Cards Chairman.

**Entry Time:** Enter all divisions between 10 a.m. and 2 p.m. on Monday, November 5, 2018. It is recommended that Holiday Show Committee members and judges enter between 9 a.m. and 10 a.m.

**Removal Time:** Entries may not be removed before Tuesday, November 6, 2018 at 4 p.m., but must be removed immediately thereafter.

**Plant Material: NO ARTIFICIAL PLANT** material is allowed in any division except for staging. Plant material is required in all divisions with **EMPHASIS on fresh material.** Plants on the state conservation list must have been grown by the exhibitor or obtained in a legal manner and so stated. Noxious plants are not allowed in any division. See state conservation website for a complete list. [www.nwcb.wa.gov](http://www.nwcb.wa.gov)

**Classification:** Horticulture entries must pass classification before being placed. Design entries must pass Classification before exhibitor leaves the staging area. The Classification Chairmen for each division checks exhibits for conformity to the schedule prior to judging. Final determination for conformance is the judges' responsibility.

**Placement:** The Horticulture Placement Committee will place Horticulture entries. Placement of Designs and Artistic Crafts will be by the exhibitor aided by the Placement Committee.

**Judging Time:** Judging will begin at 3:30 p.m. on Monday, November 5, 2018. All judging decisions are final. Awards may be withheld if not merited. Only **Required Personnel** will be allowed in the show room during judging.

**Required Personnel:** Show Chairman, Assistant Chairman, Judges Chairman, Clerks Chairman, Horticulture, Design, Education and Botanic Arts Classification Chairmen.

**Responsibility:** WSFGC will strive to assure the safety of all exhibits but assumes no responsibility for loss, damage and/or injury to persons or property.

**Dismantling:** By Show Committee.

**Donations:** Ticket donations in advance are \$8. Donations at the door are \$10. Children under 12 accompanied by an adult are free.

**Sales Room:** Set up is Monday, November 6, 2018 from 7 a.m. to 11 a.m. and is open from noon to 9 p.m. Open on Tuesday, November 6, 2018 from 9 a.m. to 4 p.m.

## AWARDS

This is a Standard Show and will be judged by NGC Accredited Judges using the Standard System of Awarding as this System is educational and encourages the highest quality of exhibits. The Standard System of Awarding allows only one first (blue), one second (red) and one third (yellow) to be awarded in each class or sub-class. Honorable Mention (white) may be given to all other meritorious exhibits.

\***First** place exhibits must score 90 or above.

\***Second** place exhibits must score 85 or above.

\***Third** place exhibits must score 80 or above.

\***Honorable Mention** must score 75 or above.

### DIVISION I – HORTICULTURE

#### NGC Top Exhibitor Awards

*(Handbook for Flower Shows, Chapter 5)*

#### General Requirements:

1. All plant materials must be fresh and grown by exhibitor.
2. Exhibit must be a blue ribbon winner scoring 95 or more.
3. Exhibit must be correctly NAMED according to its binomial name or currently accepted scientific designation.
4. Each section must have at least three (3) classes. Eligible classes are designated in the schedule.
5. An award must be withheld if no designated exhibit meets specific requirements for the award.
6. There is no minimum number of exhibits required except that the total number must meet requirements for a Standard Flower Show.

**Award of Horticultural Excellence: (1)** This Division award is offered to a named horticulture exhibit scoring 95 or more and judged to be the finest in the entire Horticulture Division; all sections eligible. The Award of Horticultural Excellence is represented by a rosette of green, orange, and blue ribbons.

**Arboreal Award: (4)** This section award is offered to a named exhibit in Sections A, C, D and E. Exhibit must be no longer than 30" and have several nodes. The Arboreal Award is represented by a rosette of two shades of green ribbons.

**Award of Merit: (2)** This section award is offered to a named exhibit in Sections F and G. Award is offered to cut non-woody specimens including vines.

One Award of Merit in each section, if merited. The Award of Merit is represented by a rosette of orange ribbons.

**Collector's Showcase Award for Collections: (1)** This section award is offered to a Collection in Section J. Each specimen must be properly named and score 95 or more. The Collection exhibit must consist of a minimum of five different cut specimens of plants in one family with like characteristics exhibited in individual containers. The Collector's Showcase Award is represented by a rosette of brown and green ribbons.

**Elfin Award: (1)** This section award is offered in classes of dwarf or miniature varieties, cultivars designated as dwarf or miniature varieties by nurseries or plant societies and/or plants with naturally small growth in Section B. The Elfin Award is represented by a small rosette of chartreuse and purple ribbons.

**Grower's Choice Award: (2)** This section award offered in classes of container-grown plants in Sections H and I. Maximum container size: 10 inches in diameter. The Grower's Choice Award is represented by a rosette of dark green ribbons.

#### Washington State Federation of Garden Clubs Horticulture Division Award

**Betty Belcher Horticulture Award: (1)** This award is offered to the named exhibit judged to be the finest in Division I. An evaluation will be made by the team of judges selecting the winning exhibit. Nominee may apply for the award by submitting a Book of Evidence by April 1, 2019. This nomination is represented by a rosette of green and brown ribbons.

#### DIVISION II – DESIGN NGC Top Exhibitor Awards

(*Handbook for Flower Shows*, Chapter 5)

##### General Requirements:

1. A blue ribbon winner, either Traditional or Creative, scoring 95 or more.
2. Eligible classes, special requirements and number of exhibits required are indicated in the schedule.
3. A minimum of three classes with at least four exhibits each is required for each award.
4. No section can be eligible for more than one Top Exhibitor Award. Exception: Holiday Excellence Award.

5. Judges must withhold an award if no exhibit meets the requirements.

**Holiday Excellence Award: (1)** This division award is offered in a Holiday Show to a design scoring 95 or more and judged to be the finest in the entire Design Division. The winning exhibit may have won another Top Exhibitor Award. The Holiday Excellence Award is represented by a rosette of red ribbons.

**Tricolor Award: (1)** This section award is offered in Section A, Classes 1, 2 and 3. All plant material used in the design must be fresh, and all general design award requirements must be met. The Tricolor Award is represented by a rosette of blue, red and yellow ribbons.

**Designer's Choice Award: (2)** This section award is offered in Sections B and C, Classes 4, 5, 6, 7, 8 and 9. All general design award requirements must be met. Designer has complete freedom to choose plant materials and other components within NGC policies. Exhibitor must follow design requirements for each class. The Designer's Choice Award is represented by a rosette of purple ribbons.

**Table Artistry Award: (2)** Table Artistry Awards are offered: one in Section D, Classes 10, 11 and 12; and one in Section E, Classes 13, 14 and 15. All general design requirements must be met with designer's choice of plant material and components. The Table Artistry Award is represented by a rosette of burgundy ribbons.

**Petite Award: (2)** Two section awards are offered: one in Section F Classes 16, 17 and 18. All general award requirements must be met. The Petite Award is represented by a small rosette of blue and white ribbons.

#### Washington State Federation of Garden Clubs Design Awards

**Carolyn Erickson All Fresh Design Award (1)** A Division Award in which fresh plant material must be **dominant** in the design. Decorative wood is not permitted. (Refer to Tricolor Rules, *Handbook for Flower Shows*, pages 46-47). Only one award will be offered. Design must score 95 or more. An evaluation will be made by the team of judges selecting the winning exhibit. Nominee may apply for the award by submitting a book of evidence by April 1, 2019 using the Carolyn Erickson All Fresh Design Award Application Form. The Carolyn Erickson All Fresh Award is represented by a rosette of hot pink ribbons.

**Phyllis Danielson Table Setting Award: (2)** Two section awards are offered: one is Section D to the outstanding functional table exhibit in Classes 10, 11 and 12; and one in Section E to the outstanding exhibition table exhibit in Classes 13, 14 and 15. The nominations must score 95 or more. Designer's choice of plant material and other components. An evaluation will be made by the team of judges selecting the winning exhibit. Nominee may apply for the award by submitting a book of evidence by April 1, 2019. The Phyllis Danielson Table Setting Awards are represented by a rosette of purple and red ribbons.

**Ellen B. Swenson Flower Arrangement Award: (1)** A Division Award is offered to the design judged to be the finest in Division II. The design must score 95 or more and be selected from the NGC Top Award winning designs. An evaluation will be made by the team of judges selecting the winning exhibit. Nominee may apply for the award by submitting a book of evidence by April 1, 2019. The Ellen Swenson Flower Arrangement Award is represented by a rosette of turquoise ribbons.

**Judith Juno Petite Design Award (1)** This award is offered to the highest scoring blue ribbon petite design. An evaluation will be made by the team of judges selecting the winning exhibit. Nominee may apply for the award by submitting a Book of Evidence by April 1, 2019. The Judith Juno Petite Design Award is represented by a small rosette of emerald green and pale peach ribbons.

### DIVISION III EDUCATION

**NGC Educational Award: (1)** This section award is offered to an Educational Exhibit in Division III, Section A, Classes 1 and 2. The exhibit must score 95 or more and must cover a minimum of 18 square feet. There must be a minimum of 2 exhibits in a show to give the award. The Educational Award is represented by a rosette of brown and white ribbons.

#### Washington State Federation of Garden Clubs Award

**Carol Klingberg Educational Award: (1)** This award is offered to the best Educational Exhibit in Division III, Section A, Classes 1 and 2. An evaluation will be made by the judges selecting the winning exhibit. Nominee may apply for the award by submitting a book of evidence by April 1, 2019. The Carol Klingberg Education Award is represented by a rosette of yellow ribbons.

### DIVISION IV BOTANICAL ARTS

#### Botanical Arts Top Exhibitor Awards

*(Handbook for Flower Shows, Chapter 5)*

#### Section A. Horticulture

##### General Requirements:

1. There must be at least 3 classes with a combined total of at least 12 exhibits.
2. Winning exhibit must score 95 or more.
3. The exhibit must be the work of one individual.

**Botanical Arts Horticulture Award: (1)** This section award is offered in Division IV, Section A. Classes 1, 2 and 3. All general Horticulture Award requirements must be met. The Botanical Arts Horticulture Award is represented by a rosette of light brown ribbons.

#### Section B Artistic Crafts

##### General Requirements:

1. Exhibits must contain some plant material.
2. Winning exhibit must score 95 or more.
3. There must be at least three classes with four exhibits each.
4. Only one may be offered and awarded per show.

**Botanical Arts Artistic Craft Award: (1)** This section award is offered in Division IV, Section C. All general Artistic Craft Award requirements must be met. The NGC Artistic Craft Award is represented by a rosette of navy ribbons with gold lettering.

#### Washington State Federation of Garden Clubs Award

**JoAnn Goldman Artistic Craft Award: (1)** This award is offered to the most outstanding blue ribbon winning Artistic Craft exhibit in Division IV, Section C. An evaluation will be made by the judges selecting the winning craft. The exhibitor may apply for the award by submitting a book of evidence by April 1, 2019. This nomination is represented by a rosette of lavender and purple ribbons.



## Section C Photography

### General Requirements

1. Each section must consist of at least 3 classes with at least four 4 exhibits in each class.
2. Exhibit must be the work of one individual.
3. Photographs must relate to NGC goals and objectives.
4. Awarded to the highest scoring exhibit in each section.

**Botanical Arts Photography Award: (1)** This section award is offered in Division IV, Section C. All general Photography Award requirements must be met. The NGC Photography Award is represented by a rosette of black and white ribbons.

### Washington State Federation of Garden Clubs Award

**Terry Critchlow Photography Award: (1)** This award is offered to the most outstanding photography exhibit in Division V, Section D. An evaluation will be made by the judges selecting the winning photo. The exhibitor may apply for the award by submitting a book of evidence by April 1, 2019. This nomination is represented by a rosette of two shades of blue.

## DIVISION I HORTICULTURE

### Horticulture Rules

*Complete Horticulture Exhibit Policies  
Handbook for Flower Shows page 55*

1. Horticulture entries must be fresh plant materials grown by the exhibitor. Fresh plant material may never be treated.
2. Entry cards may be obtained from District Directors or printed from the State website on white cardstock and filled out in advance with waterproof ink or pencil.
3. All plant material must have been in the exhibitor's possession at least 90 days except for combination plantings which must have been in exhibitor's possession and grown together at least six weeks. Arboreal (woody ornamentals) specimens and troughs must have been in the exhibitor's possession for 6 months.

4. Exhibitors must furnish their own clear glass containers of appropriate size for specimens.
5. In order to receive an NGC Top Exhibitor Award, exhibits must be identified by genus, specific epithet and/or variety or patent trade-marked names. Common names may also be added.
6. Good grooming and conditioning are important and may be the difference between a blue and an honorable mention ribbon. No enhancement of foliage is permitted. Check for foliage requirements.
7. Horticulture exhibits shall be appropriate for species, cultivar/variety or type or as required by the schedule.
8. All entries should consist of one specimen unless otherwise stated.
9. The Horticulture Classification Committee Chairman and/or General Show Chairman are free to subdivide classes by color, form, size, cultivar, variety or other distinguishing characteristics.
10. If a plant is considered a flowering plant, it should be exhibited as a flowering specimen. Foliage plants may flower, but should be exhibited as foliage plants if they are grown for their leaves.
11. Specimens with a class designation in the schedule may not be entered in the 'Any Other Worthy' class.
12. If entry is unusual, please list characteristics on a 3" x 5" card placed with exhibit.
13. Exhibitor may make more than one entry per class or sub-class if each is a different variety/cultivar, type or color. Exhibitors are limited to a maximum of 15 entries.
14. Cut specimens should not have foliage below the water line.
15. Unobtrusive wedging provided by the exhibitor is permitted (plastic wrap, plugs, corks, Styrofoam, etc.). Weights may be used to stabilize bottles. Clear marbles are suggested.
16. Length of specimen should be in pleasing proportion to container and no more than 30 inches.

17. Maximum size of containers for container-grown plants shall not exceed **10 inches in diameter**. Self-multiplying and other multiple plants are permitted. Double potting is permitted but inner pot must not be visible.
18. Wilted specimens will be removed from the show.
19. Complete Exhibit Policies are listed in Chapter 6 of the *Handbook of Flower Shows*.

#### Section A. "Christmas Trees"

**Conifers (needled or scaled), must be ornamental (no forest trees accepted).**

Maximum length 30" with several nodes, measured from tip to cut end staged hanging on a wire mesh panel provided by the Show Committee.

Eligible for the NGC Arboreal Award

#### Class 1. *Abies* (Fir)

- a. *Abies concolor* (White Fir)
- b. *Abies grandis* (Grand Fir)

2. All designs must contain some plant material. **Emphasis is on fresh plant material** which is never treated or embellished in any way.
3. Each design **MUST** be the work of one individual but plant material need not have been grown by the exhibitor.
4. Contrived flowers or other forms constructed of recognizable plant material (fresh or dried) are permitted unless otherwise stated. A contrived flower must not resemble any known cultivar/variety.
5. Landscapes or scenes are not permitted in the Design Division. A single flower or a container-grown plant used alone is not a "Design."
6. Plants listed on the state conservation/native plant list may be used in design if grown by the exhibitor or obtained in a legal manner and so

marked. Noxious plants are not allowed.

7. The American flag and other national flags are **NOT** allowed in any design.
8. Religious symbols used must be displayed in a respectful manner and in accordance with policies of local religious organizations.
9. All properties are furnished unless otherwise stated. See individual classes for specific descriptions. Designer may provide additional staging but must use the properties provided by the Committee and use only the space allowed by the schedule.
10. If the designer is unable to fulfill an assignment, it is the designer's responsibility to find a replacement and notify the Advance Entry Chairman of the replacement.
11. Featured objects, accessories, lighting or other motorized features (with use of battery pack) are permitted unless otherwise stated.
12. Plant materials used in a design **MUST** be listed on a separate 3"x5" card placed with the exhibit. Card furnished by the Show Committee.
13. Use of expensive flatware on Flower Show table exhibits is discouraged. Flatware made of plastic, wood, inexpensive metal, etc. is permitted.
14. An exhibitor may enter as many classes as desired, but only one exhibit per class or sub-class.
15. See Chapter 7 of the *Handbook for Flower Shows* for complete exhibit policies and rules.
16. Designer is on his/her honor that the design being entered has not been previously entered or previously judged in an NGC Flower Show.

## Glossary

**Accessory:** A subordinate object in an arrangement, something other than plant material, container, base, special staging and other mechanics.

**Artificial:** Made or manufactured to simulate natural appearance. Artificial flowers, fruit or foliage are not permitted in a Standard Flower Show.

**Background:** The surface against which an exhibit is seen. The background may be used as a frame of reference or incorporated into the design.

**Condition:** The physical state of plant material at the time of judging. Refers to cleanliness, freedom from blemish and disease, tears or insect damage.

**Container Grown:** Plants grown in a container over a period of time, singly or in combination.

**Contrived Flower:** One made from fresh, dried and/or treated, but recognizable plant material.

**Creative Design:** (HB page 71 and 72)

**Cultivar:** A hybrid engineered by man. The first letter of name is to be capitalized, with full name enclosed in single quotes.

**Decorative Unit:** A completed floral design and other components such as candles used on a table exhibit.

**Decorative Wood:** All-inclusive term for most dried wood that includes weathered wood (wood that has had its surface color, texture and/or form altered by weather, wind, sun) and/or polished or otherwise treated wood, selected for interesting form and color.

**European Traditional Design – English –** Designs were symmetrical, usually triangular, elegantly formal and informal. Plant material was often of only one (1) color with variations. (HB page 70)

**European Traditional Design - Italian Renaissance** (14<sup>th</sup> and 15<sup>th</sup> Century) Warm intense colors of richness, grandeur. Dried flowers and tropical fruits combined with flowers as in Della Robbia wreaths. Container of bronze, marble and Venetian glass. (HB page 70)

**Exhibition Mode Table:** A table setting artistically arranged to provide a creative coordination of all components without consideration of functional placements.

**Floor Design:** a large design placed on the floor. **NOT** a design staged on a pedestal or base. (HB page 78)

**Framed Spatial Design** a Creative Design organized as a single unit suspended in a frame or frame-like structure.

**Functional Mode Table:** A table exhibit arranged for the actual service of food, table could actually function for dining as displayed. Must include a decorative unit. (HB page 76)

**Genus:** A closely related group of species; the first term in a botanical name. The first letter is capitalized and underlined if written on an entry tag.

**Grooming:** Cleaning of plant material or containers by removing soil, spray residue, insect damage, dead florets and leaves, etc.

**Parallel Design:** A design consisting of three or more grouping of plant material and optional components with a strong parallel placement.

(HB page 75)

**Petite Design:** A design reduced in size to no more than 12" in height, width and depth. Staging not included with the dimensions given, but must be in pleasing proportion to the 12" maximum.

**Reflective Design:** A Creative Design containing materials that reflect, give back images of light or other components to the viewer. (HB page 75)

**Transparency Design:** A Creative Design with see-through elements integral to the design and permitting some components to be viewed through others. (HB page 77)

**Treated Plant Material:** Dried plant material artificially altered by use of any substance.

**Underlay:** Fabric, cardboard, etc. placed under a design.

**Underwater Design:** A Creative Design having some or all plant material and other optional component/s submerged in water. Plant material and other components under water must contribute to the overall design and are selected for their lasting quality. (HB pages 71 and 72)

**Wedging:** Inserting a small piece of material in the neck of a horticulture exhibit bottle to hold a cut specimen in proper pose. It must not detract from the horticulture specimen.

**Note:** If a "specific" design type is not asked for in a class, then the exhibitor is free to choose any NGC Design style, Traditional or Creative, but must always be within *Handbook for Flower Shows* rules and policies.
