

Here are some figures and facts about the unfolding story: THE NUMBERS AND THE SYSTEM

The U.S. Customs and Border Protection Over the first 8 1/2 months of fiscal year 2014, 52,193 unaccompanied minors have been taken into custody -- a 99 percent increase over 2013. In Texas' Rio Grande Valley alone, where most border crossings now occur, apprehensions have increased 178 percent over last year, with 37,621 unaccompanied minors apprehended so far this year.(2014)

The soaring number of migrant children has strained the system, forcing the federal government to scramble to open additional emergency facilities across the country and prompting President Barack Obama to request Tuesday for an emergency appropriation of \$3.7 billion to fund the operation. ORR also has seen its caseload jump sharply in recent years, rising from an average of between 7,000 and 8,000 unaccompanied children from FY 2005 through 2011 to 24,668 last year, according to figures provided by HHS. This year, officials estimate, the office will receive at least 60,000 referrals.

NBC News Gender: About three-quarters of minors served by ORR are boys. THE BEGINNING OF THE SHAKEDOWN BY LAWMAKERS..... Under the Homeland Security Act of 2002, Congress transferred the care and custody of unaccompanied minor immigrants from the former Immigration and Naturalization Service (INS) to HHS.

In 2008, the William Wilberforce Trafficking Victims Protection Reauthorization Act expanded the responsibilities of HHS, and required that the children must be placed “promptly” into the “least restrictive setting,” that is in the best interest of the child. The act, a bipartisan effort that expanded on earlier efforts to protect unaccompanied children, was signed by George W. Bush shortly before he left office.

THE COST TO TAXPAYERS ILLEGAL AND UNPRECEDENTED...SEE AMOUNTS LATER. LAW IGNORED AS FOLLOWS

1907. Title 8, U.S.C. 1324 (a) Offenses

Title 8, U.S.C. § 1324(a) defines several distinct offenses related to aliens. Subsection 1324(a)(1)(i)-(v) prohibits alien smuggling, domestic transportation of unauthorized aliens, concealing or harboring unauthorized aliens, encouraging or inducing unauthorized aliens to enter the United States, and engaging in a conspiracy or aiding and abetting any of the preceding acts. Subsection 1324(a)(2) prohibits bringing or attempting to bring unauthorized aliens to the United States in any manner whatsoever, even at a designated port of entry. Subsection 1324(a)(3).

Alien Smuggling -- Subsection 1324(a)(1)(A)(i) makes it an offense for any person who -- knowing that a person is an alien, to bring to or attempts to bring to the United States in any manner whatsoever such person at a place other than a designated port of entry or place other than as designated by the Commissioner, regardless of whether such alien has received prior official authorization to come to, enter, or reside in the United States and regardless of any future official action which may be taken with respect to such alien.

The Vera Institute, a nonprofit think tank focused on criminal justice issues, estimates that about 40 percent of unaccompanied minors initially admitted into ORR custody are eligible for some kind of relief, including asylum or “special immigrant juvenile status,” which allows children to later apply for legal residence.

PUBLISHED: 11:39 EDT, 9 June 2014 | President Barack Obama is calling tens of thousands of illegal-immigrant children languishing in temporary U.S. holding pens an ‘urgent humanitarian situation,’ but Republicans are pointing the finger of blame squarely at the White House.

Obama instituted an immigration policy that the GOP says enticed tens of thousands of Central American children to cross America’s southern border illegally without any parents to guide them.

More than 33,000 have been picked up in Texas alone since October. The U.S. border patrol says its forces are overwhelmed, and the courts are bracing for a flood of immigration cases from children held in temporary detention facilities designed to handle a fraction of the numbers. Sanitation problems are beginning to rear their ugly heads.

Obama rolled out a controversial Deferred Action for Childhood Arrivals (DACA) program in 2012, allowing many illegal immigrants who came to the U.S. as minors to escape deportation for two years. The White House gave them another two-year window last week.

As a result, say some GOP leaders, America’s system for handling illegal immigration has been strained to the breaking point and is attracting hundreds of new illegal-immigrant children every day.

Compared to the year before Obama’s policy took effect, twelve times as many kids are coming north illegally this year.

A half-century-old section of a U.S. Air Force base in Texas is now a holding and processing center for thousands of children who managed to enter the U.S. alone. The same is true of a Navy base in California.

And a makeshift detention center in Arizona holding 700 illegal immigrant children has ordered 2,000 mattresses to keep up with an expected influx in the coming months.

Judge: US ‘has simply chosen not to enforce ... border security laws’

In a landmark court ruling in December, a federal judge ruled against the Department of Homeland Security for releasing a Salvadoran girl to her mother.

The mom had hired a smuggler to transport her daughter into the U.S., and was herself in the country illegally.

U.S. District Judge Andrew Hanen wrote that ‘this court is quite concerned with the apparent policy of the Department of Homeland Security of completing the criminal mission of those who are violating the border security of the United States.’ ‘The DHS,’ Hanen added, ‘should enforce the laws of the United States – not break them.’ Many of the children there were sleeping on plastic boards.

According to the Associated Press, toothbrushes and toothpaste hadn’t arrived yet and were expected Monday.

Hundreds of children had not bathed in days, and were taking turns using just four showers. Tony Banegas, Honduras’ honorary consul in Phoenix, told the AP that there were 236 Honduran children there on Saturday, including an 8-year-old.

Republicans on Capitol Hill are beyond angry. Leaked photos from the base, which were obtained by the Breitbart.com news blog, show hundreds of children holed up in crowded concrete rooms, many of them sleeping on the bare floor without blankets or pillows. 'The recent surge of children and teenagers from Central America showing up at our southern border is an administration-made disaster,' Virginia GOP Rep. Bob Goodlatte, who chairs the House Judiciary Committee, told Fox News last week.

Should Obama's two-year 'amnesty' for illegal immigrant minors crossing the border be abolished?

'Word has gotten out around the world about President Obama's lax immigration enforcement policies and it has encouraged more individuals to come to the United States illegally,' Goodlatte said in a statement.

'Enforcement at the border and in the interior of the U.S.,' not 'another bureaucratic task force' is needed, he claimed.

Arizona Rep. Paul Gosar, who sits on the House Oversight and Government Reform Committee, said Friday that 'instead of having an application of the immigration law, we are taking mothers and children and dumping them ... and violating the rule[s] over and over.'

70,000 Kids Will Show Up Alone at Our Border This Year. JULY/AUGUST 2014 ISSUE

The Administration remains greatly concerned

by the rise in unaccompanied children from Central America who are In Guatemala, the Vice President is meeting with regional leaders to address the rise in the flow of unaccompanied children and adults with their children to the United States, to discuss our work together with the countries of Central America, and to discuss our efforts to help address the underlying security and economic issues that cause migration. The Obama administration is projecting that it will need to cope with at least another 75,000 UACs illegally crossing the U.S.-Mexico border in FY 2017.

The U.S.-Mexico border has experienced a surge in illegal immigration from Central America in recent years with UACs and "family units" crossing into the U.S., seeking to stay. UACs from noncontiguous countries in the are granted special treatment once apprehended in the U.S., and placed in the care of — often other illegal immigrant — parents and sponsors ostensibly to await immigration hearings.

As Rush details, "From 8,000 in FY 2008, the number of apprehended unaccompanied alien children (UACs) grew to 69,000 in FY 2014. After a slowdown last year (around 40,000 apprehended), border officials are expecting significant increases throughout FY 2016 and into FY 2017 (up to 75,000, if not more). According to DHS, the number of UACs coming across the border almost doubled in FY 2016 compared to the same period in FY 2015."

While immigration activists and Democrats blame the influx on "push factors" like violence in the migrants' home countries. Immigration hawks and Republicans have pointed to the Obama administration's dilution of immigration law and executive amnesty for the migration.

The Senate Subcommittee on Immigration and the National Interest, chaired by noted immigration hawk Sen. Jeff Sessions (R-AL), recently found that just 3.6 percent of the UACs apprehended illegally entering the U.S. over the

past 2.5 years have been sent back to their home. At the base, children are provided with three hot meals and two snacks a day. They can call home twice a week. They have access to mental health clinicians. The Obama administration expects as many as 80,000 of these 'unaccompanied minors' to cross the border in 2014, according to the Christian Science Monitor. That number is twelve times what it was in 2011, the year before Obama announced his deferred-action plan.

CONNING TAX PAYERS AND AMERICAN CITIZENS IN PLAIN SIGHT...WAKE UP CHRISTIANS!

The administration now estimates the holding facilities where the youngsters are being held cost taxpayers \$252 per child per day, far more than the cost of a hotel and more than the children could expect to earn in two weeks of hard work picking crops, work that many were slated to do. Facing the question of whether to deport the minors or play a game of catch-and-release, the administration has set aside \$2 million to pay for their lawyers.

'We're taking a historic step to strengthen our justice system and protect the rights of the most vulnerable members of society,' Attorney General Eric Holder said Friday in a statement.

'How we treat those in need, particularly young people who must appear in immigration proceedings – many of whom are fleeing violence, persecution, abuse or trafficking – goes to the core of who we are as a nation.'

THE FIX WAS IN!

Obama's 'deferred action' program for minors, which he announced in a fanfare-laden June 15, 2012 Rose Garden press conference, applies only to children who came to America before mid-2007.

'It makes no sense to expel talented young people, who, for all intents and purposes, are Americans,' the president said then.

Over 400 children a day are coming and as many as 60,000 will cross the Mexican border illegally this year, but Capitol Hill is rife with fears that the message was garbled by the time it reach Guatemala, Honduras and other countries where poverty runs rampant. Many children traveling north on their own hope the policy will include them.

That's what 'coyotes,' the smugglers who bring them in, are telling them to expect, according to Tania Chavez, a representative with La Union del Pueblo Enteron, told KRGV-TV. in southern Texas.

May 2, 2016 Report: Taxpayer Cost for Each Illegal 'Unaccompanied Child' Budgeted at \$17,613

As the influx of unaccompanied illegal immigrant minors from Central America has increased, so too has the cost to assist each migrant, according to a new report from the Center for Immigration Studies.

CIS reveals that the cost per "unaccompanied alien child" has more than doubled since FY 2010, when the cost per UAC was \$8,217. CIS projects that the cost in FY 2017 will reach \$17,613. CIS senior researcher Nayla Rush, the author of the report, reached the cost per UAC by looking at the total budget requests for UACs in FY 2017 and the number of UACs expected to illegally cross into the U.S. in FY 2017.

"The Unaccompanied Children (UC) program FY 2017 request is \$1.226 billion in funding, which is an increase of \$278 million from the FY 2016 enacted level of \$948 million," the report reads. "Also included in this FY 2017 Unaccompanied Children program budget request is a contingency fund triggering additional funds not to exceed \$400 million. It is expected \$95 million will be used from this contingency fund in FY 2017."

On June 2, 2012 President Obama described it as an "urgent humanitarian situation," asking Congress for an additional \$1.4 billion to deal with the influx and creating a multiagency taskforce, led by the Federal Emergency Management Agency, to coordinate the federal response. The surge was already in full swing One of the 38,833 unaccompanied minors apprehended by the Border Patrol in fiscal year 2013. That was a 59 percent jump from the year before, and a 142 percent increase from fiscal 2011; no one knows how many more kids avoided Border Patrol detection, or never got that far. This year,(2014) officials have told advocates they anticipate the numbers to double again, to as many as 74,000 unaccompanied children.* That's equivalent to every single student in Dallas' 81 public middle and high schools getting up and walking across the border in a single yea. A budget brief for HHS's FY 2015 budget request, estimated that the agency would need \$868 million to care for unaccompanied immigrant children, the same amount appropriated in FY2014 but up from \$376 million in FY2013. \$2.8 billion – to operate the program. But on May 30, the Congressional Research Service reported, the Office of Management and Budget requested more than twice that amount -- In seeking a \$3.7 billion emergency appropriation on Tuesday to address the crisis, the White House requested \$1.8 billion for the HHS/ORR program alone for the remainder of the fiscal y

PRAYER POINTS

Pray for Branson Conference Sponsors and attendees to come forth. Is Obama the nation's DIVIDER??? Our theme is Bridging the Divide. That our leaders would know God and serve Him;

- That God would give them wisdom and surround them with godly counselors;
- That they would stand boldly and courageously in the face of evil, without backing down from righteousness; and

Pray for God's people to turn back to Him. 2 Chronicles 7:14 says: "... if My people who are called by My name will humble themselves, and pray and seek My face, and turn from their wicked ways, then I will hear from heaven, and will forgive their sin and heal their land." This promise is not contingent upon lost people coming to Jesus. It's completely dependent upon us--God's people--humbling ourselves, praying, seeking God's face, and turning from our wicked ways!

God wants us to be hot on fire for Him. Therefore, when you pray, pray for revival in the Church. Pray for Christians everywhere to get right with God; to return to their first love; and to seek Jesus with all their hearts.(Read my letter of hope to America for more.)

Pray for God's people to turn back and take a stand for HIM>>>>
Proverbs 11:11 says, "By the blessing of the upright the city is exalted, but it is overthrown by the mouth of the wicked." If a city can be lifted up when God's people bless it, how much more a nation? We as God's people need to bless our nation.

Blessing our nation is a very practical thing. Therefore, pray that God's people will bless America in practical ways.

For example, pray:

- For individuals whom God is calling to run for office to answer that call;
- For people to answer God's call to become entrepreneurs, providing jobs for others;
- For Christians to get involved in civic duties, so they witness for Jesus in those spaces; and
- For people even to buy American-made goods whenever possible.

Ask God to raise up the leaders He wants in office, and to bring down the leaders He doesn't want in office.

The Bible tells us specifically that it is one of God's jobs to promote certain people, according to His choosing, and to bring others down. Psalm 75:6-7 says, "For exaltation comes neither from the east nor from the west nor from the south. But God is the Judge: He puts down one, and exalts another."

Also, Daniel 2:20-21 says, "Daniel answered and said: 'Blessed be the name of God forever and ever, for wisdom and might are His. And He changes the times and the seasons; He removes kings and raises up kings; He gives wisdom to the wise and knowledge to those who have understanding.'"

Therefore, when you pray, ask God to raise up and bless every leader who suits His purposes for our nation--and to bring down every leader who does not.

According to 1 Timothy 2, we should always pray for all leaders--even for those leaders who lead unrighteously. It is not God's will that any should perish, but that all should come to repentance (2 Peter 3:9). We should always ask God to save and have mercy on individual leaders.

However, the Bible specifically says that bringing down unrighteous government is just as important to God as raising up righteous government. Therefore, we should pray both sides of this Scripture. "God, raise up righteous leaders, and remove those leaders from their offices who work against You, in Jesus' name." Ask God to teach us how to disciple this entire nation for Him. The Great Commission was not just a command to disciple people; it was a command to disciple nations. Matthew 28:18-20 says:

"And Jesus came and spoke to them, saying, 'All authority has been given to Me in heaven and on earth. Go therefore and make disciples of all the nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, teaching them to observe all things that I have commanded you; and lo, I am with you always, even to the end of the age.' Amen."

Therefore, we need to pray that God will show us how to influence entire nations for Him. How can we use each sphere of society--media, arts, business, government, religion, etc--to show people His glory? The Lord will show us if we pray.
