Pelosi and congressional delegation make unannounced trip to Afghanistan in outreach to allies after Trump's decision on Syria House Speaker Nancy Pelosi (D-Calif.) visited Jordan this weekend. Pelosi's office said it's a

bipartisan group of lawmakers, though Mac Thornberry (R-Texas), the ranking member of the House Armed Services Committee, is the only Republican listed as being on the trip. Per Pelosi's office, committee chairs in the delegation are: Reps. Eliot Engel (D-N.Y.), of the House Foreign Affairs; Bennie Thompson (D-Miss.), of the House Homeland Security; and Adam Schiff (D-Calif.), of the House Intelligence panel.

Committee members also in the delegation are Reps. Ron Kind (D-Wis.), of the House Ways and Means; Susan Davis (D-Calif.), of the House Armed Services; Elaine Luria (D-Va.), of the House Armed Services

Committee; and Stephen Lynch (D-Mass.), of the House Oversight and Reform subcommittee on national security.

House Speaker Nancy Pelosi (D-Calif.) led an unannounced congressional visit to Afghanistan and Jordan over the weekend, highlighting her sharp disagreement with President Trump over his abrupt removal of U.S. troops from northern Syria and Turkey's subsequent attacks on Kurdish enclaves.

In Afghanistan, the delegation met with Afghan President Ashraf Ghani, chief executive Abdullah Abdullah, Defense Secretary Mark T. Esper, top U.S. military commanders and diplomats, senior Afghan government officials and civil society leaders. The delegation also traveled to Camp Morehead to meet with Resolute Support Mission troops. "Our delegation received briefings from

Nancy Pelosi is facing accusations of cronyism after a solar energy project, which her brother-in-law has a stake in, landed a \$737 million loan guarantee from the Department of Energy, despite the growing Solyndra scandal. The massive loan agreement is raising new concerns about the use of taxpayers' money


as vast sums are invested in technology similar to that of the doomed energy project.

The investment has intensified the debate over the effectiveness of solar energy as a major power source.

The SolarReserve project is backed by an energy investment fund where the Minority Leader's brother-in-law Ronald Pelosi is second in command.

PCG Clean Energy & Technology Fund (East) LLC is listed as one of the investors in the project that has been given the staggering loan, which even dwarfs that given to failed company Solyndra. Other investors include one of the major investors in Solyndra, which is run by one of the directors of Solyndra. Steve Mitchell, who served on the board of directors at the bankrupt energy company, is also managing director of Argonaut Private Equity, which has invested in the latest project. Since Solyndra has filed for bankruptcy has been asked to testify about the goings on at the firm by two members of the House and 'asked to provide documents to Congress'. The artist's impression shows the incredible size of the giant solar power plant, which is being bankrolled by President Obama's green jobs fund.

But the joint announcement by Energy Secretary Steven Chu comes just two days after the doomed Solyndra project, which cost the taxpayer \$528 million from the same cash pot, was meant to be completed. The loan agreement comes as questions are raised about the effectiveness of solar power as a major energy source. Although solar energy plants are typically

comparatively cheap to operate, they are extremely expensive to build. The project approval came as part of \$1 billion in new loans to green energy companies yesterday. Republican critics of the President Obama's solar energy program have voiced their outrage at the new loans while the Solyndra scandal is still being investigated.

They have raised concerns that the Department of Energy is rushing through the approval of loans before stimulus funds expire on Friday.

While the departments insists the projects are being properly vetted, some lawmakers have written to express concern that they vast loans are not being adequately scrutinized. 'The administration's flagship project Solyndra is bankrupt and being investigated by the FBI, the promised jobs never materialized, and now the Department of Energy is preparing to rush out nearly \$5 billion in loans in the final 48 hours before stimulus funds expire — that's nearly \$105 million every hour that must be finalized until the deadline,' said Florida representative Cliff Stearns, who is chairman of the investigations subcommittee of the House Committee on Energy and Commerce.

The shocking scale of spending Solyndra lavished on the factory it started building alongside Interstate 880 in Fremont, California, has been revealed. When it was completed at an estimated cost of \$733 million, including proceeds from the company's \$535 million U.S. loan guarantee, it covered 300,000 sq ft, the equivalent of five football fields. It had robots that whistled Disney tunes, spa-like showers with liquid-crystal displays. John Pierce, 54, a San Jose resident who worked as a facilities manager at Solyndra, said: 'The new building is like the Taj Mahal.' Designed to make far more solar panels than Solyndra got orders for, the site is now empty and

U.S. taxpayers may be stuck with it. Solyndra filed for bankruptcy protection on September 6, leaving in its wake investigations by Congress and the FBI. Mr Chu said the two projects will create about 900 construction jobs and at least 52 permanent jobs.

He added: 'If we want to be a player in the global clean energy race, we must continue to invest in innovative technologies that enable commercial-scale deployment of clean, renewable power like solar.' The 110-megawatt Crescent Dunes project will use the sun's heat to create steam that drives a turbine, SolarReserve, which is based in Santa Monica, California. Mr Pelosi is one of several controversial figures set to benefit from the huge loan agreement.

The loan approvals came just two days before the renewable energy loan program approved under the 2009 economic stimulus law is set to expire. At least seven projects worth more than \$5 billion are also waiting to be approved. California-based solar panel maker Solyndra Inc went bankrupt after receiving its money and laid off 1,100 workers. The firm is now under investigation by the FBI.

It was the first renewable-energy company to receive a loan guarantee under a stimulus-law program to encourage green energy and was frequently touted by the Obama administration as a model. Vice President Joe Biden spoke by satellite at its groundbreaking ceremony.

Red flag warning issued, PG&E power outages could start Wednesday

Pacific Gas & Electric Co. could preemptively shut off power Wednesday in 16 Northern California counties in an attempt to curb fire dangers, officials

said Tuesday as they continued monitoring dangerous weather conditions.

PG&E customers in San Mateo, Napa and Sonoma counties were among the 189,000 businesses and homes that could be affected this week in what would be the second widespread blackout this month. A utility spokeswoman said officials expected to make a decision on Wednesday, but customers across 16 counties were notified by phone, text and email messages that they could be affected.

The number of potentially affected customers decreased from 201,000 as the weather forecast changed, company spokeswoman Melissa Subbotin said. Customers who were not notified were not in a potentially affected area, she added. Officials suggest customers prepare for outages that could last more than 48 hours. “We continue to monitor weather,” Subbotin said. “Weather is very dynamic ... changing around the clock.”

Any shut-offs will be less extensive than the cuts that affected more than 738,000 customers in 30 California counties earlier this month, officials said.

Temperatures and winds are expected to increase Wednesday as humidity levels drop, according to the National Weather Service. Weather service officials issued a

red flag warning for North Bay, East Bay and Santa Cruz Mountains Wednesday through Thursday due to the conditions.

## RED FLAG WARNING

Issued for North Bay, East Bay, and Santa Cruz Mountains Wednesday through Thursday. Very dry, gusty offshore winds will create critical fire weather conditions.

The warning begins at noon Wednesday in the North Bay, 3 p.m. in the East Bay and 7 p.m. in the Santa Cruz Mountains, according to the weather service. All warnings will last until 4 p.m. Thursday. On Tuesday afternoon, the weather service updated its fire weather outlook for Wednesday to “critical” levels for Sonoma and Napa.

In a letter Tuesday, Gov. Gavin Newsomffl implored PG&E CEO Bill Johnson to enhance communication with customers in anticipation of another shut-off. “PG&E’s lapse in planning to provide adequate, accurate and accessible information to its customers and the public was inexcusable,” Newsom wrote. “In the

same vein, PG&E’s communications with local and tribal governments lacked even the most basic elements of emergency management organization.” Newsom urged utility officials to adopt communication initiatives outlined by the California Public Utilities Commission and offered state resources to help with the possible shut-offs. He blasted the company for not following up with customers who were warned of losing power earlier in the month, but never did, and for having “unhelpful” information on its website during the shut-offs in early October for those who were able to access it. The company’s shareholders have an obligation to customers after the “failed execution” of the earlier shut-offs, Newsom wrote. He suggested utility officials offer \$100 rebates or credits to residential customers and \$250 to small businesses “for the hardship suffered.” Earlier Tuesday, a PG&E spokeswoman said “some customers were having trouble accessing” the company’s website for about 45 minutes, a day after utility officials announced customers would be redirected to a special site to accommodate high volumes of traffic. Troves of visitors paralyzed the company’s website during the shut-off earlier this month. “We worked with our third-party solution providers to address the issue,” wrote spokeswoman Andrea Menniti in a tweet. The most dangerous weather is expected Wednesday evening into Thursday afternoon, said Carolina Walbrun, a National Weather Service meteorologist. Wind gusts in parts of the North Bay could blow at 50 to 60 mph and 30 to 40 mph in parts of the East Bay and Santa Cruz Mountains. “Our primary concerns are going to be poor humidity recovery,” Walbrun said. “It’s going to be really, really dry.” Utility officials said the potential shut-offs would start at different times in different locations.

PG&E officials said Tuesday that shut-offs could affect 7,533 residential and business customers and 140 medical baseline customers who are dependent on equipment that needs power in Napa County; 907 customers and 15 medical customers in San Mateo County; and 28,460 customers and 927 medical customers in Sonoma County.

About 10 activists gathered Tuesday morning at the California Public Utilities Commission's offices in San Francisco, where they decried the shutoffs.

Nishikant Sheorey, an organizer with Utility Justice Campaign, which advocates for energy democracy issues, said people affected by the recent shut-off described have it as frustrating but something they have to accept because climate change is making wildfires worse.

"That is not an inevitable consequence of climate change," Sheorey told reporters. "It's an inevitable consequence of climate change in the context of a utility that puts ... the greed of shareholders above the need of ratepayers."

PG&E's blackouts have emboldened Sheorey and other activists who oppose a new California law, AB1054, that authorizes a \$21 billion fund to shield the state's major utilities from future wildfire costs.

The commission is set to vote Thursday on whether to extend a surcharge on customers' bills to support the new wildfire fund. Activists view the charge, which would have eventually expired if not for AB 1054, as a bailout and they plan to protest the commission's meeting in Redding.
