The SPLC is a dangerous group because it creates a "Hate Map" listing "hate groups." Mark Potock, with the SPLC, in an interview admitted: "Our criteria for a 'hate group,' first of all, have nothing to do with

All hate groups have beliefs or practices that attack or malign an entire class of people, typically for their immutable characteristics."

SPLC Uses Their Hate Map to Advance a Political Agenda

One example of the SPLC's tactics is its "Interactive Hate Map." The SPLC Hate Map is a scam designed to portray political organizations that disagree with the SPLC in a negative light. Pitched as an easy-to-use list of hate groups, it's really just a mash-up of organizations that hold political views opposed to those pushed by the SPLC. There are a few genuine hate groups tossed in – most of them neo-Nazi organizations. But the presence of a small number of actual hate groups merely seems calculated to lead map users to the conclusion that mainstream political opponents of the SPLC are guilty by association.

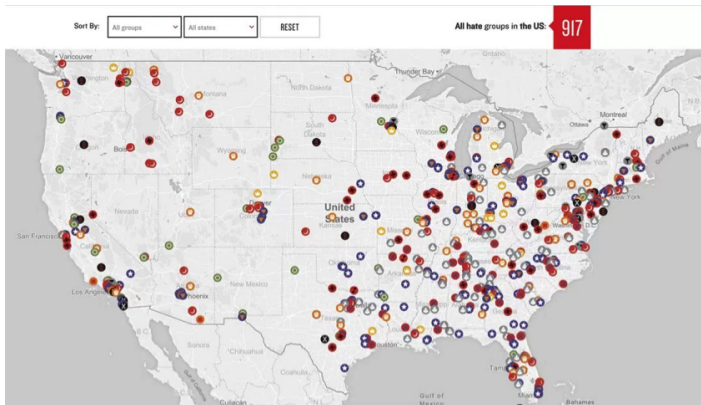

MIAMI - With hate groups resurfacing in the United States, we take a look at where hate groups exist inside Florida.

The Southern Poverty Law Center released a map showing where every hate group in America is stationed in every state.

According to the center, there are 40 hate groups inside Florida, and 917 total in the country. The groups vary from anti-muslim to neo-nazi, white nationalist and KKK groups.

This list was compiled using hate group publications and websites, citizen and law enforcement reports, field sources and news reports. Groups that appear in the center of states represent statewide groups.

An attorney for the Liberty Counsel told Local 10 news that the Liberty Counsel is not a hate group.

"We hate no one, and love all people. All people have inherent dignity and deserve respect because they are created by God in His image," Richard Mast said in an email.

President Donald Trump, facing mounting pressure from Republicans and Democrats alike, did what declined to do over the weekend during an event at the White House on Monday when he directly condemned white supremacists and neo-Nazis in a brief statement to reporters.

“Racism is evil -- and those who cause violence in its name are criminals and thugs, including KKK, neo-Nazis, white supremacists, and other hate groups are repugnant to everything we hold dear as Americans,” Trump said in response to the attacks in Charlottesville, Virginia, over the weekend. “Those who spread violence in the name of bigotry strike at the very core of America,” Trump said.

The comments came in a hastily scheduled White House event in the Diplomatic Reception Room, where Trump -- speaking with the help of a teleprompter -- spoke straight to camera after meeting with FBI Director Christopher Wray and Attorney General Jeff Sessions to discuss the Department of Justice’s civil rights investigation into the attack. “To anyone who acted criminally in this weekend’s racist violence, you will be held fully accountable,” said, *“Justice will be delivered.”* Trump had been excoriated for his unwillingness to condemn the groups behind the violent protests that left one woman dead who was hit by a car allegedly driven by a man with ties to white supremacy groups.

After blaming the violence “on many sides” Saturday, Trump stayed silent for close to 48 hours, letting his trademark bluntness and campaign pledges to call terrorism what it is succumb to silence and vagueness.

Trump was asked by reporters after he spoke why he waited so long to condemn these hate groups by name and did not respond.

I have never spoken to Channel 10 News or been contacted by them. I was stunned to see my name there. I then was told that the same list on was CNN and Amazon just to name a few.

A professor from a liberal university was on Tucker Carlson, Fox News said she used this list to warn her students about the dangers of fascists.

The Southern Poverty Law Center (SPLC), a liberal, Alabama-based legal advocacy nonprofit and civil rights watchdog, recently refused to designate the radical leftist movement known as “antifa” as a “hate group,” despite acknowledging that its members use violence and oppose free speech.

However, Cohen refused to label antifa a “hate group” since its members do not discriminate on the basis of race, sexual orientation, or other categories protected by anti-discrimination law. (What a joke? All organized mobs are freedom loving protesters with rights to burn down towns, college campuses, riot against law enforcement.)

WND reported last month when SPLC’s president, Richard Cohen, defended his group’s attacks on Christians.

He wrote in a Huffington Post commentary that Christians deserve the designation because they “sow the seeds of hate” for, among other things, adhering to a biblical perspective on homosexuality.

Mark Potock is on video in a public meeting stating: -Sometimes the press will describe us as monitoring hate crimes and so on. I want to say plainly that our aim in life is to destroy these groups, to completely [destroy them...](#)”

During the Obama administration, the SPLC frequently visited the White House. The SPLC even peddled its false ideological propaganda for some in the military until their extremism and false reporting got the group removed.

The SPLC has no bona fides to make such determinations. It is not a governmental organization using a rigorous criteria to create its lists, and it is not a scientifically oriented organizations.

The SPLC doesn’t even pretend to identify groups on the political left that engage in “hate.” Mosques or Islamist groups that promote radical speech inciting anti-Semitism and actual violence are not listed by the SPLC even though many have been publicly identified after terrorist attacks. Radical, violent leftist environmentalists or speech suppressing thugs – like the rioting “antifa” movement – receive no mention from the SPLC.

The Philanthropy Roundtable recently published an article about the SPLC pointing out the false labeling. The SPLC even labeled famed surgeon Dr. Ben Carson as a “hater.” The SPLC rakes in millions of dollars each year and has huge financial reserves, causing some to wonder what nonprofit work the SPLC does.

Groups and public figures who disagree with the SPLC's agenda are put on its "hate" map.

But SPLC's "hate" map designations have been linked to two mass shooting attempts in Washington, including on members of Congress, and many groups on the list are fighting back. Suddenly, it's the SPLC that's being called a "hate" organization, retractions are being demanded from newspapers that cite its propaganda and lawsuits are being filed.

On Tuesday, it was talk-radio icon Rush Limbaugh, who had had enough, saying SPLC "is treated as the Vatican" by many in the national media.

"The Southern Poverty Law Center is perhaps one of the biggest hate groups on the left. They tar and feather and slander right-wing groups and call them hate groups," he said. "They've got a map on their website, and whenever a right-wing group that says or does anything that the Southern Poverty Law Center, which is a bunch of leftist freaks, all you have to do is disagree with them and you are called a hater."

These are the people that want to shut you up if you say something they disagree with. You don't even have to be saying it about them.

"Basically all you have to do is be a prominent conservative or run a prominent conservative 501(c)(3) fundraising organization. If your conservative group raises money, then the Southern Poverty Law Center is out to destroy you.

The National Center for Life and Liberty recently filed a lawsuit on behalf of D. James Kennedy Ministries against the SPLC and others.

Citing the Civil Rights Act of 1964, the suit charges religious discrimination by "trafficking in false or misleading descriptions of the services offered under the ministry's trademarked name; and for defamation pursuant to Alabama common law arising from the publication and distribution of information that libels the ministry's reputation and subjects the ministry

to disgrace, ridicule, odium, and contempt in the estimation of the public."

In June, SPLC supporter James Hodgkinson shot Rep. Steve Scalise., R-La.; Zach Barth, a staff member for Congressman Roger Williams; former congressional staff member Matt Mika; and two U.S. Capitol Police officers at a Republican congressional members practice for a charity baseball game just months ago. SPLC had demonized Scalise for promoting white supremacy and clearly tried to infer "that Rep. Scalise is a so-called 'hater.'" Hodgkinson had "liked" SPLC's Facebook page.
