FACTS WE NEED TO GET TO CHRISTIANS:

New Mexico Changes are coming to the way public school students are tested in New Mexico. Thursday, New Mexico Governor Michelle Lujan Grisham signed two executive orders scrapping the state's current test, the Partnership for Assessment of Readiness for College and Careers, also known as the PARCC test. Governor Lujan Grisham said the change will lead to far more teaching and far less testing. The executive orders also mean that the PARCC test will no longer be used to evaluate teacher performances, which was a controversial policy under former New Mexico Governor Susana Martinez.

Opponents of the PARCC test argued that teacher evaluations weighed too much on the PARCC test. Del Hansen has been an educator in Las Cruces for more than 40 years. He recalled the problems he noticed with the PARCC test when it was first implemented. "We were expected to change for the test," Hansen said. "More and more teachers began teaching the test and I thought that was very restrictive of curriculum. I was very much against that." Hansen said he was ecstatic when he heard the news that Gov. Lujan Grisham scrapped the PARCC test. Hansen believes the move will ultimately help in the evaluation process of New Mexico teachers. "There are lots of ways to evaluate teachers besides scores of students on a PARCC test, so I don't think it will make any difference at all," Hansen said. ["I thought the PARCC test was a highly inappropriate way to evaluate teachers in the first place."](#)

But not everyone agrees with Governor Lujan Grisham's decision to end the PARCC test. Chris Ruskowski served as New Mexico's Public Education Secretary under former New Mexico Governor Susana Martinez. Ruskowski believes some of the problems the state could face will be the cost to taxpayers in establishing a new test and the impact to students in their preparation for this school year's standardized test. "What I heard in visiting all 89 of our school districts, in visiting hundreds of schools, is that our teachers, and our parents and our families want some degree of stability and continuity," Ruskowski said. "Today's announcement has the potential to create chaos and uncertainty." In March, New Mexico students will most likely have to take some

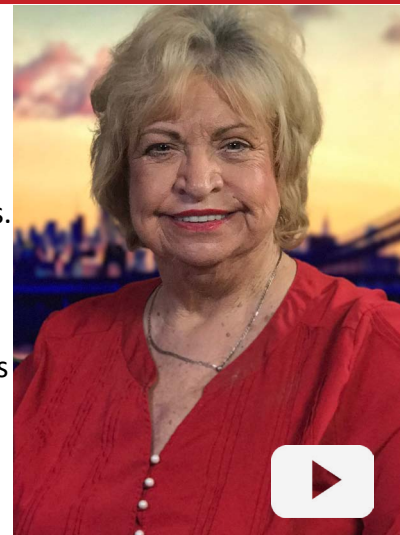
components of the PARCC test while the governor's team works with federal officials to implement a new evaluation system for students. Thursday, Governor Lujan Grisham also announced that Lieutenant Governor Howie Morales will assume the duties and responsibilities of the Secretary of Public Education until a permanent secretary is named.

New Mexico governor pulls National Guard troops from border

The New Mexico Army National Guard Liaison Team visited the U.S. Border Patrol El Paso Sector Intelligence Operations Center to meet and coordinate preparations for their upcoming deployment in support border enforcement April 7, 2018. (Agent Marcus Trujillo/U.S. Border Patrol) SANTA FE, N.M. — The governor of New Mexico ordered the withdrawal of the majority of the state's National Guard troops from the U.S. border with Mexico on Tuesday, in a move that challenges President Trump's description of a security crisis. Gov. Michelle Lujan Grisham announced the partial withdrawal shortly before Trump's State of the Union address. Her Republican predecessor deployed National Guard troops to the border in April 2018



at Trump's suggestion, and 118 remained there before Tuesday's reversal. "New Mexico will not take part in the president's charade of border fear-mongering by misusing our diligent National Guard troops," Lujan Grisham said in a statement. **Pentagon sending another 3,750 troops to US-Mexico border.** The Pentagon says it will send 3,750 more troops to the U.S.-Mexico border to put up another 150 miles of concertina wire and provide other support for Customs and Border Protection. At the same time, the governor said a small contingent — around a dozen guardsmen — will remain in the southwestern corner of the state to assist with humanitarian needs in a remote corridor for cross-border immigration. She also mobilized state police to assist local law enforcement.



“I recognize and appreciate the legitimate concerns of residents and officials in southwestern New Mexico, particularly Hidalgo County, who have asked for our assistance, as migrants and asylum-seekers continue to appear at their doorstep,” the governor said.

the approach of the Valentine's Day anniversary of the mass shooting at Parkland's Marjory Stoneman Douglas High School in Florida. The arrival in January of a Democratic governor to succeed a pro-gun rights Republican (Susanne Martinez) has opened the door to calls for broader background checks on private gun sales and initiatives to remove firearms from the hands of people who may be suicidal or seen as a danger to others.

Additional initiatives would ensure teachers cannot carry firearms at schools and expand child neglect laws to encompass the secure storage of household firearms. Many of the bills are confronting public skepticism and opposition from rural sheriffs in a state with a strong culture of gun ownership. Here are things to know about the key proposals:

Private gun sales

State law says background checks are required on sales by licensed gun dealers to prevent illegal purchases by people including felons or patients treated involuntarily for severe mental disorders. Democratic lawmakers aim to close an existing loophole that allows private sales between unlicensed individuals — often arranged through online marketplaces for guns. Opponents of the initiative fear it would infringe on 2nd Amendment rights or might interfere with the innocuous sharing of weapons at sporting events or youth gun clubs — a point vigorously refuted by the bill's sponsors, who say it applies only to sales where money is exchanged. The House approved the initiative 41-25. A Senate vote is anticipated this week. Gov. Michelle Lujan Grisham supports the measure.

Child access

Initial deliberations began Tuesday on a bill designed to keep guns out of the hands of young children by holding parents responsible for securing household firearms. The bill from Democratic Rep. Linda Trujillo of Santa Fe would amend child abuse and neglect statutes to require reasonable actions from parents or guardians to secure firearms against access by children. The bill suggests trigger-lock mechanisms or gun locker containers as examples of reasonable precautions, but leaves "reasonable" up to interpretation.

Republican Rep. Gregg Schmedes of Tijeras says that could lead to unfair sanctions against parents in high-crime areas who want to have guns unlocked and at the ready. Trujillo says parents who run afoul of the law could eventually be found guilty of a misdemeanor for interfering with the protection of a child.

Extreme risk

Nine states have passed laws over the past year allowing police or household members to seek court orders requiring people deemed threatening to temporarily surrender their guns, bringing the total to 14. New Mexico would join that movement under a bill that supporters say holds promise for reducing suicides and homicides alike. Ahead of a House vote this week, the bill is running into opposition from dozens of sheriffs who say it endangers law enforcement and treads on individual constitutional rights. Proponents of the bill include Police Chief Mike Heal of Aztec who was a first responder to a December 2017 high school shooting in which a 21-year-old gunman killed two students before killing himself. Democratic House Speaker Brian Egolf says the bill is in keeping with current law allowing police or psychiatrists to rescind gun-possession rights for the mentally ill.

Domestic violence

The House has approved a bill that would ban gun possession for people under permanent protective orders for domestic violence. A similar initiative was vetoed in 2017 by Republican Gov. Susana Martinez, a former district attorney and strong supporter of gun rights. The bill includes stiffer penalties for felons found in illegal possession of a firearm. Teachers would not be able to carry firearms at schools, under an additional bill from Trujillo that sets gun protocols for contract security employees and campus police.

Insight USA Intercissors have been very active in our fight against these Bills, especially the abortion and euthanasia Bills. Liberal New Mexico has been a hot-bed for support of even third trimester abortion, which is really infanticide. Our Governor has also recalled all National Guard troops off the southern border. Our Border patrol officers and many ranchers contend that she is sabotaging the safety of everyone

in the state. One person in Ruidoso initiated a call for IMPEACHMENT Petition that immediately had 19,000 signatures. The Democratic House Speaker refuses to consider the action of course. We are also an “oil producing state” and new proposed laws seek to greatly hinder production. Governor Grisham wants a totally GREEN state before she’s done.

Stop Infanticide! Urge Your senators to Support and Vote for the “Born-Alive Abortion Survivors Protection Act” (S. 311)

Early next week the Senate will vote on Sen. Ben Sasse’s (R-Nebr.) “Born-Alive Abortion Survivors Protection Act” (S. 311) to stop infanticide. Urge your senators to support and vote for this bill that will stop infanticide of babies born alive after failed abortions! Does this happen? Yes! Can it be stopped? Yes! Despite the horrors of Dr. Kermit Gosnell in 2013, who killed at least 3 babies born alive, and the 2015 Center for Medical Progress’ videos of Planned Parenthood workers dissecting precious infants for body parts - some of whom were possibly born alive – our federal laws in this country still lack any teeth to hold abortionists accountable.

On the 46th anniversary of “Roe v. Wade”, Governor Andrew Cuomo (D-N.Y.) began a radical abortion trend across the states by signing into law the Reproductive Health Act which allows abortion through all stages of pregnancy and removes explicit protections for babies born alive following a failed abortion. Additionally, in defending a Virginia Democrat bill that allows abortion up through birth, Governor Ralph Northam (D-Va.) stated what appeared to be an endorsement of letting born-alive babes die when he said: “If a mother is in labor, I can tell you exactly what would happen. The infant would be delivered. The infant would be kept comfortable. The infant would be resuscitated if that’s what the mother and the family desired, and then a discussion would ensue between the physicians and the mother.” Since then, several more states have introduced bills to expand late-term abortions including Arizona, Illinois, New Mexico, and Vermont. This is unacceptable! As a response, Senator Sasse introduced the “Born-Alive Abortion Survivors Protection Act” (S. 311). Congress

must pass this bill to stop abortionists from killing, harvesting organs, or denying medical care to infants born alive who survive an attempted abortion. The brutal killing of these children is something our government should not tolerate. It is essential that we enforce and strengthen former President George W. Bush’s 2002 Born-Alive Infants Protection Act that recognized and defined in federal law that a child surviving a botched abortion is a full person. This law, however, did not create legal enforcement tools. Who would have thought born-alive infants would be killed? But they are. Senator Sasse’s “Born-Alive” bill provides the necessary enforcement tools by requiring health care practitioners to treat babies born alive after failed abortion attempts with the same care they would give a baby born at the same gestational age and creates penalties for the intentional killing of infants born alive. The bill also gives the mother of a child born alive a private right of action to seek relief in case an abortionist was to kill her born-alive infant! Your U.S. senators need to hear from you! Please email your senators and urge them to vote FOR Senator Ben Sasse’s “Born-Alive Abortion Survivors Protection Act” (S. 311). Thank you for your vital work in defense of innocent human life.
