Diseases, “stands to lose 100 million dollars” on a coronavirus vaccine from Bill Gates because he invested in it. “If everyone can be healed with the Malaria drug and a Z pack, there will be no need for the vaccine if we could use drugs already on the market that helps heal 98 percent of the coronavirus (sic) patients,” reads the image. “That’s why he’s been so hesitant to put his seal of approval on this form of treatment that has shown to drastically improve hundreds of people’s symptoms.”

The post was flagged as part of Facebook’s efforts to combat false news and misinformation on its News Feed. As a member of the White House’s coronavirus task force, Fauci has tempered expectations for the use of chloroquine or hydroxychloroquine to treat COVID-19 patients. The drugs, which are used to treat conditions like malaria and lupus, have shown some promise in alleviating coronavirus symptoms, but the research is not conclusive.

PolitiFact has seen a lot of misinformation about public officials’ financial interests in hydroxychloroquine. Fauci has become a popular target for coronavirus disinformation, so we wanted to check out this post, too. The Facebook post draws a false connection between Gates’ philanthropy and Fauci’s public remarks about hydroxychloroquine. There is no evidence that Fauci is personally financially invested in a coronavirus vaccine, and scientists still don’t know if hydroxychloroquine is effective in treating COVID-19.

### Gates Foundation supports coronavirus research

The Bill and Melinda Gates Foundation is indirectly supporting the National Institute of Allergy and Infectious Diseases by funding a group that is helping the agency develop a potential coronavirus vaccine. But there is no evidence that Fauci himself stands to profit

The Gates Foundation said in a Feb. 5 statement that it is investing up to \$100 million for “the global response to the 2019 novel coronavirus.” That includes efforts aimed at improving detection and treatment of the virus in addition to vaccine development. “The foundation will commit up to \$60 million to accelerate the discovery, development and testing of vaccines, treatments and diagnostics for 2019-nCoV (the formal name for the coronavirus),” the statement reads.

While the Gates Foundation has supported the National Institute of Allergy and Infectious Diseases in the past, the philanthropy told PolitiFact in an email that it does not provide funding to the agency now, even though the agency is currently developing a COVID-19 vaccine. During his March 11 testimony to the House Oversight and Reform Committee, Fauci said it could take a year and a half to roll out a safe and effective coronavirus vaccine. There are 70 vaccines in development, according to the World Health Organization — three of which are in clinical trials.





The first trial began in mid-March. The potential vaccine was developed by National Institute of Allergy and Infectious Diseases scientists in partnership with pharmaceutical company Moderna, Inc.

According to a statement from the National Institutes of Health, which houses the National Institute of Allergy and Infectious Diseases, manufacturing for the potential vaccine was supported by the Coalition for Epidemic Preparedness Innovations, a foundation that funds vaccine research. The Gates Foundation said in its February release that it will allocate some of its research and development funding to the coalition. A Facebook post claims Fauci has downplayed the potential use of chloroquine and hydroxychloroquine to treat coronavirus patients.

## **SECTION 1. Short title.**

This Act may be cited as the “COVID–19 Testing, Reaching, And Contacting Everyone (TRACE) Act”.

## **SEC. 2. COVID–19 testing and contact tracing using mobile health units.**

(a) In general.—The Secretary of Health and Human Services, acting through the Director of the Centers for Disease Control and Prevention, may award grants to eligible entities to conduct diagnostic testing for COVID–19, to trace and monitor the contacts of infected individuals, and to support the quarantine of such contacts, through—

(1) mobile health units; and

(2) as necessary, testing individuals and providing individuals with services related to testing and quarantine at their residences.

(b) Permissible uses of funds.—A grant recipient under this section may use the grant funds, in support of the activities described in subsection

(1) to hire, train, compensate, and pay the expenses of individuals; and

(2) to purchase personal protective equipment and other supplies.

(c) Priority.—In selecting grant recipients under this section, the Secretary shall give priority to—

(1) applicants proposing to conduct activities funded under this section in hot spots and medically underserved communities; and

(2) applicants that agree, in hiring individuals to carry out activities funded under this section, to hire residents of the area or community where the activities will primarily occur, with higher priority among applicants described in this paragraph given based on the percentage of individuals to

be hired from such area or community.

(d) Distribution.—In selecting grant recipients under this section, the Secretary shall ensure that grants are distributed across urban and rural areas.

(e) Federal privacy requirements.—Nothing in this section shall be construed to supersede any Federal privacy or confidentiality requirement including the regulations promulgated under section 264(c) of the Health Insurance Portability and Accountability Act of 1996 (Public Law

104–191; 110 Stat. 2033) and section 543 of the Public Health Service Act (42 U.S.C. 290dd–2).

(f) Definitions.—In this section

(1) The term “eligible entity” means—

(A) a Federally qualified health center (as defined in section 1861(aa) of the Social Security Act (42 U.S.C. 1395x(aa)));

(B) a school-based health clinic;

(C) a disproportionate share hospital (as defined under the applicable State plan under title XIX of the Social Security Act (42 U.S.C. 1396 et seq.) pursuant to section 1923(a)(1)(A) of such Act (42 U.S.C. 1396r–4));

(D) an academic medical center;

(E) a nonprofit organization (including any such faith-based organization);

(F) an institution of higher education (as defined in section 101 of the Higher Education Act of 1965 (20 U.S.C. 1001));

(G) a high school (as defined in section 8101 of the Elementary and Secondary Education Act of 1965 (20 U.S.C. 7801)); or

(H) any other type of entity that is determined by the Secretary to be an eligible entity for purposes

of this section.

(2) The term “emergency period” has the meaning given to that term in section 1135(g)

(1)(B) of the Social Security Act (42 U.S.C. 1320b–5(g)(1)(B)).

(3) The term “hot spot” means a geographic area where the rate of infection with the virus that causes COVID–19 exceeds the national average.

(4) The term “medically underserved community” has the meaning given to that term in section 799B of the Public Health Service Act (42 U.S.C. 295p).

(5) The term “Secretary” means the Secretary of Health and Human Services.

(g) Authorization of appropriations.—To carry out this section, there are authorized to be appropriated—

(1) \$100,000,000,000 for fiscal year 2020; an

(2) such sums as may be necessary for each of fiscal year 2021 and any subsequent fiscal year during which the emergency period continues

## **Chinese company to buy Texas oil fields in \$1.3 billion deal**

A Chinese investment firm is shelling out \$1.3 billion to buy giant oil fields in Texas, reflecting growing interest from China in U.S. energy resources.

Yantai Xinchao will acquire oil assets in the western Texas Permian Basin that are currently owned by Tall City Exploration and Plymouth Petroleum. The deal is part of a larger transaction between Yantai Xinchao and a second Chinese firm, according to a stock exchange filing on Saturday.

The purchase, which includes oil fields in the state's Howard and Borden counties, has already been approved by the U.S. Committee on Foreign Investment, the filing said. Many smaller Chinese oil and gas companies are looking for deals abroad as a way to combat tough competition from giant state-owned energy firms, and tight government regulations back home.

China's largest state-owned oil and gas firms, meanwhile, are snapping up resources in countries including Mozambique and Kazakhstan. The Permian Basin, one of the oldest oil fields in the U.S., has enjoyed a revival as shale gas exploration and other drilling technology has improved.

Yantai Xinchao shares were suspended from trading last Friday to allow for the asset restructuring and oil field purchase. The company expects shares to be halted for about one month, and plans to release periodic updates on the restructuring, according to another stock exchange filing

The United States shale revolution is over. Production in the Permian Basin, which spreads across West Texas and Southeast New Mexico, has been slowing for months, but the novel corona virus took things from bad to much worse for U.S. shale. The oil price shock that followed the spread of the COVID-19 pandemic, combined with a massive global oil glut spurred by a spat between with learning OPEC+ member countries of Russia and Saudi Arabia, drove West Texas Intermediate oil prices down to a previously unthinkable -\$37.63 a barrel earlier this month. While shale prices have since moderately rebounded, the Permian Basin is still in bad shape. The oil fields that made the United States the biggest crude oil producer in the world is now seeing tens of thousands of fired and furloughed employees as the region is rocked by a sweep of bankruptcies across the shale sector. Last week CNBC reported that "the oil industry shakeout is just beginning with more production cuts and bankruptcies ahead," detailing that "U.S. oil companies are already paring back spending and closing wells, but wild trading in the futures market was a warning to curb production now because the world at some point will not be able

to store any more supply."

Just because the U.S. oil industry has hit a rough patch, however, doesn't necessarily mean that the West Texas shale play is all played out. In fact, it stands to reason that, as competition dries up and blows away like so many tumbleweeds, Big Oil may step in and buy up faltering shale independents.

**Obama corruption exposed?!** On the FOX News program “Sunday Morning FUTURES,” host Maria Bartiromo pulled no punches talking about FBI officials who investigated President Trump’s former national security advisor Gen. Bartiromo then asked her guest, Sen. Lindsey Graham (R-SC), when he would begin calling witnesses to appear before the Senate Judiciary Committee to hold them accountable for their attempted coup.
