(Riders must be a current 2014 financial member of LEG Inc.)

1. **Freestyle to Music** – dress code as per normal members days i.e. club polo shirt  
Level to be nominated - Prep, Preliminary, Novice, Elementary, Medium, Advanced.  
(Please type in NOTES section of online entry which level you are riding at)
  2. **Exhibition Class** – freestyle to music in costume (approved helmets and boots are to be worn in this class). Category to be nominated:  
Individual  
Pas De Deux  
Quadrille  
(Can nominate for more than one category)  
(Please type in NOTES section of online entry which level you are riding at, Riders Names or “Team” Name)
  3. **Prix Caprilli Introductory Level Test** – Walk Trot test with 3 jumps – will be executed in a 20m x 60m arena not 20m x 40m as stated. Maximum jump height 30cm
- Note: for classes 4 – 7 cannot enter same test at both heights either ride 30cm or 50cm class)**
4. **Prix Caprilli Training Level Test** – Walk Trot Canter test with 3 jumps. Maximum jump height 30cm (cannot enter class 5)
  5. **Prix Caprilli Training Level Test** – Walk Trot Canter test with 3 jumps. Maximum jump height 50cm (cannot enter class 4)
  6. **Prix Caprilli First Level Test** – Walk Trot Canter test with 3 jumps. Including lengthen trot and canter, leg yield. Maximum jump height 30cm (Cannot enter class 7)
  7. **Prix Caprilli First Level Test** – Walk Trot Canter test with 3 jumps. Including lengthen trot and canter, leg yield. Maximum jump height 50cm (cannot enter class 6)
- 8. Pairs Preliminary Test**

**Depending on entry numbers it would be expected that the competition will commence at 1pm.**

**All tests will be ridden in the indoor arena**

**All competitors will win a ribbon. There will be Master, Senior & Junior Divisions**

*(Results of this competition will not qualify for End Of Year Awards)*

**Entry Fee: \$10 per test (not per rider).**

## Conditions of Entry:

1. This event will be conducted under current EA rules as amended. ([www.equestrian.org.au](http://www.equestrian.org.au)). Approved helmets and boots are to be worn in all tests.
2. Other acceptable conditions for Members Day Only are available from the website: [www.legs.org.au](http://www.legs.org.au)
3. One rider per horse. Change of rider or horse will be allowed up to commencement of class.
4. Maximum 3 tests per horse. Maximum of 2 consecutive levels of the Caprilli tests may be entered
5. The committee reserves the right to restrict class sizes if necessary. Classes will be restricted in numbers, based on a "first in basis" as per receipt date of entries. A reserve list will be maintained.
6. EA now have a no smoking policy. This policy does not allow smoking in the area in the arena, including gear check and in or around the canteen areas.
7. Please present to Gear Check 10 minutes prior to your draw time.
8. Please be prepared to ride early in the event of scratchings.
9. Horse Health Declaration to be accepted together with release and waiver indemnity when entering through [www.nominate.com.au](http://www.nominate.com.au). – *remember DO NOT TAKE SICK HORSES TO AN EVENT*. By accepting this declaration you declare that the horse/s on this entry will only be brought to the event if they are in good health. You will be giving your authorisation for the designated OC Steward to call for veterinary inspection of the horse/s on this entry and in your care should they be showing signs of illness at any time during the course of the event. You also agree to pay any veterinary fees incurred as a result of this.
10. Members may bring horses that are not entered for the event only if a Visiting Horse Form and Horse Health Declaration is completed and handed into office upon arrival. Both forms can be downloaded from [www.legs.org.au](http://www.legs.org.au)
11. Bridle numbers are not required for this event

## Biosecurity Recommendations for Competitors

Primary responsibility for biosecurity at horse events lies with the horse owners and competitors long before the event takes place.

### Practise good biosecurity

- Practise good hygiene and decontaminate equipment thoroughly.
- Do not share equipment, including food and water containers, between horses.
- Avoid use of communal water troughs.
- If using communal hoses, avoid touching buckets when filling with water to avoid spreading disease from bucket to bucket.

### Monitor horse health

- *Do not take sick horses to an event.*
- Notify an event official if a horse is suspected of being sick.
- Isolate the sick horse and seek veterinary advice.
- Isolate any equipment that has been in contact with the sick horse.
