

## **TERMS AND CONDITIONS**

## **Easter Colouring Competition**

- 1. The Promoter of this prize draw is Crown water and Coffee (registered in England and Wales under company number 5121722 and with its registered office at Cedar House, Long Lane, Shaw, Newbury, Berkshire, RG142TF) (the "Promoter").
- 2. The Promoter is offering those who enter this promotion a chance to a Tassimo Coffee machine.
- 3. To enter this prize draw, entrants must complete the downloadable colouring page and enter their name and email address, and telephone number as stated on the form and either post or e-mail their entry back to the address provided on the form.
- 4. Entrants must be UK residents, and must specify there age category. This promotion is not open to any employees of the Promoter or any of their families, agents or anyone else connected with this prize draw.
- 5. One entry allowed per person. Incomplete, illegible, misdirected or late entries will not be accepted.
