Terms and Conditions of Instrument Hire

- Herefordshire Music Service/Encore instruments are hired subject to availability with a <u>minimum hire</u> <u>period of 2 months</u>. For drum kits, electric guitars and electric pianos the minimum hire period is 4 months.
 The Hirer is the parent/carer of the pupil for whom the instrument is being hired.
- 2. The Hirer is the parent/carer of the pupil for whom the instrument is being hired.
- 3. The cost of hire (at Sept 2016) for Herefordshire school pupils is £7.00 per month for string instruments and £10.00 per month for all other instruments, and <u>must</u> be paid for monthly by direct debit. If you only wish to hire an instrument for the minimum hire period we can accept a cheque/cash payment for the whole of the hire period. Please make cheques payable to 'Encore Enterprises'.
- 4. Where the school is in receipt of pupil premium for a child from a low income family or a 'Looked after Child', the child is entitled to free instrument hire (subject to availability). The child must be learning with an Accredited Teacher in a Music Service Partner School. A £25 refundable deposit is required and is refunded when the instrument is returned in a satisfactory condition. Please tick the appropriate box on the form and enclose a cheque with your application along with proof of entitlement. Your school may be able to pay this deposit on your behalf, please check with your school.
- 5. Direct debit payments will be taken from the Hirer's bank account on the first day of the month irrespective of the day the hire was initiated or terminated i.e. if you collect an instrument on 15 April, you will not be charged until 1 May. The direct debit will appear on your bank statement as "Herefordshire UA". We require 14 days' notice to terminate a direct debit.
- 6. If the direct debit is cancelled by the hirer and we do not receive either the instrument or any communication from the hirer within 7 days from the date of cancellation, you will receive notification that the direct debit has been reinstated and charges will commence 14 days later.
- 7. Instruments are normally delivered to schools on a fortnightly basis (term time only), however they can be collected from our office by parents/carers or instrumental teacher.
- 8. The instrument can only be collected/delivered on receipt of a completed Instrument Hire Form and Direct Debit Instruction or deposit cheque, in the case of a Pupil Premium bursary.
- 9. When the instrument is no longer needed, it is the hirer's responsibility to inform the office and <u>arrange for its return</u>. Leaving the instrument at school, informing the music teacher or school office is not sufficient and you will still be liable for payment if you have not informed Encore Enterprises that the instrument is being returned. Once we have received the instrument, we will cancel the direct debit or refund the deposit charge.
- 10. The Hirer agrees to take reasonable care to safeguard the musical instrument.
- 11. The Hirer is responsible for replacing 'disposable' items such as strings, reeds etc.
- 12. The Hirer must ensure that the instrument is adequately insured against theft, loss and damage, or be prepared to cover the loss themselves.
- 13. Encore will arrange and pay for repairs needed as a result of fair wear and tear. Instruments requiring attention <u>must</u> be returned to Encore to be repaired by our instrument technicians. <u>It is essential that no repairs are made by the Hirer, tutor or other instrument repairer.</u> Please contact us.
- 14. The instrument will not be available for you to purchase when you complete the hire.
- 15. <u>Please note</u>: where an instrument is hired to an adult, other organisation or an out of county pupil the hirer may be required to return the instrument (with one month's notice) should a Herefordshire school pupil require it.
- 16. Please ensure you inform Encore immediately of any change to your contact or bank details.

The Direct Debit Guarantee

- This Guarantee is offered by all Banks and Building Societies that take part in the Direct Debit Scheme. The efficiency and security of the Scheme is monitored and protected by your own Bank or Building Society.
- If the amounts to be paid or the payment dates change ENCORE will notify you 10 working days in advance of your account being debited or as otherwise agreed.
