



2019-20 PSR Letter of Commitment

Players/guardians should review all club-specific financial obligations, policies and/or contracts prior to signing below.

PSR LETTER OF COMMITMENT

The PSR Letter of Commitment applies to all indoor junior girls' and boys' clubs operating in the Puget Sound Region/USA Volleyball.

A "commitment" is a fully executed PSR Letter of Commitment, accepting a club's offer to a player/guardian by the Club Director or designee. PSR will not recognize any other agreements or contracts, oral or written, between a club and a player/guardian.

Clubs are required to use this document. Each club must give the player/guardian 72-hours from the time of the offer to submit the signed PSR Letter of Commitment to the club. Clubs may not rescind the offer prior to the 72-hour waiting period. Clubs may not present the PSR Letter of Commitment prior to the first day of scheduled tryouts. **Players/guardians should review all club-specific financial obligations, policies and/or contracts prior to signing the PSR Letter of Commitment.**

- The first date a player and guardian are allowed to sign the PSR Letter of Commitment and/or make a financial payment is the first date of tryouts for their respective age division.
- A player and guardian may not sign a PSR Letter of Commitment for more than one club.
- Once a player and guardian have signed a PSR Letter of Commitment for a club, they are considered a member of that club until the completion of the club season (see below).

PLAYER / GUARDIAN – THIS DOCUMENT CANNOT BE SIGNED BEFORE THE FIRST DAY OF TRYOUTS FOR YOUR AGE DIVISION. AT NO POINT, CAN A PLAYER BE REQUIRED BY A CLUB TO SIGN THIS DOCUMENT BEFORE THE OPENING DAY OF TRYOUTS LISTED BELOW.

2019-20 TRYOUTS:

First day of allowable tryouts:

ALL AGES (boys)	SATURDAY, SEPTEMBER 21, 2019, no early than 8:00 am and beyond
U14s and younger (girls)	SATURDAY, OCTOBER 26, 2019, no early than 8:00 am and beyond
U15s and older (girls)	SUNDAY, NOVEMBER 24, 2019, no early than 10:00 am and beyond

- Basic Penalty.** I understand that by signing this letter I am committed to joining the club named within this document for the entire club season. If I participate with another club, I may be subject to suspension for the remainder of the season. The PSR Junior Volleyball season runs from tryouts through the player's USAV competition schedule.
 - Early Signing Penalty.** A player who signs a Letter of Commitment before the first day of allowable tryouts for their age group listed above may be subject to suspension for the entire season. A club representative may not require an athlete to sign a Letter of Commitment prior to the first day of tryouts for their age group.
 - Only One Letter of Commitment Permitted.** A player who signs more than one PSR Letter of Commitment with more than one club may be subject to suspension for the entire club season.
 - Falsification of Letter of Commitment.** If I falsify any part of this Letter of Commitment, including the date, I understand that I may be subject to suspension for the entire club season.
- Verbal Commitments.** A player may commit verbally to a club. A verbal commitment is **not binding**. The player may revoke the commitment at any time, before signing a PSR Letter of Commitment, without penalty.
- PSR Transfer Rule.** I understand that if after signing this PSR Letter of Commitment I wish to transfer to a different club, I will abide by the Transfer Rule set forth in the PSR Junior Handbook.
- Parent/Guardian Signature Required.** My parent or legal guardian is required to sign this Letter of Commitment if I am less than 18 years of age at the time of signing.
- Binding Agreement.** I understand that I have signed this Letter of Commitment with the club and not with a particular individual. If the coach or any player(s) leaves the team, I remain bound by the provisions of this document. Any player who wants to transfer clubs after signing a Letter of Commitment must abide by the guidelines set in the Junior Handbook/Transfer Rule.

I certify that I have read all terms and conditions in this document. I have discussed them with the club representative named within, and I fully understand, accept, and agree to be bound by them.
