#### SHIPPING DISPLAY MATERIALS

- Materials must be shipped via a carrier of your choice.
   Return shipping must be pre-arranged by carrier.
- All packages should be sent to CSI ONLY, not the hotel directly, and should include a full return address, including the shipper's name. Please Contact Christina Booth at CSI for further questions: 800-471-7330
- If shipping multiple boxes, in lower left corner, identify boxes: 1 of 4; 2 of 4; 3 of 4, etc.
- CSI staff will receive items beginning Thursday, July 12<sup>th</sup>, 2018. No packages will be accepted prior to this date.
- All packages will be delivered to exhibit booths by CSI on Thursday evening by 6PM.
- All mail/package forms need to be completed by the quest.
