It's Not a Tax Deduction, It's a Dollar-for-Dollar Tax Credit!

What's the difference? Let's say you're in a 10% state tax bracket, married filing joint, have \$800 AZ state income tax liability And give \$800 to a charitable organization:

Tax Deductible Gift:	Tax Credit Eligible Gift:
\$800 tax liability - \$800 deduction (10%)	\$800 tax liability - \$800 (100% credit)
\$720 tax still owed	\$0 NET TAX OWED!

You save \$720 for the same gift. It really costs you nothing!

Arizona Tax Credit for Contributions to Qualifying Charitable Organizations

The Arizona Charitable Tax Credit, previously known as the Working Poor Tax Credit, allows you to donate to a qualifying charitable organizations such as Grand Canyon Council, BSA Outreach, LLC. For you donation you can receive dollar for dollar Tax Credit on your state tax and also claim it on your federal tax.
