5. Keep your space clean during the day, and clean it thoroughly at the close of the day. YOU ARE RESPONSIBLE FOR YOUR OWN TRASH REMOVAL AT THE END OF THE DAY.
6. Lunch and refreshments are available for purchase in the Church Basement.
7. Smokers are requested to use ashtrays to help keep the grounds clean.
8. Church policy limits representation of only one vendor per franchise. Vendors are limited to exhibiting only those items stated on their registration form. No solicitation is permitted. Misrepresentation of the exhibit is subject to forfeiture of space and fee.
