

LAW OF PROSPERITY

Article 1 – Application Requirements *[added at 09.04.2018, 16:45 (Eve Timezone)]*

- a) All capsuleers may submit their applications for joining Exploration Movement regardless of their status (Alpha or Omega) and race (Minmatar, Gallente, Caldari or Amarr).
- b) Application of any alternative character (Alt) will be refused. If any alternative characters invitation accepted in any way, that character shall be expelled.
- c) This rule shall not apply to any alternative character whose application accepted before 09.04.2018.

Article 2 – Capsuleer Support Program

- a) All members are free to take and use any ship from the “Santa Maria Port”.

Ships for Explorers	:	Probe
Ships for Miners	:	Venture
General Ships	:	Thrasher, Slasher, etc.

- b) All members are free to use all fittings from the “Leonardo da Vinci Fitting Hall” (Specific for Exploration & Mining) and “Wright Brothers Fitting Hall” (For general fitting modules).

Fittings for Explorers	:	Core Probe Launcher I, Core Scanner Probe I, Cargo Scanner I, Nanofiber Internal Structure I, Relic Analyzer I, Salvager I, Scan Pinpointing Array I, Small Gravity Capacitor Upgrade I, Data Analyzer I, Relic Analyzer I, etc.
Fittings for Miners	:	EP-S Gaussian Scoped Mining Laser, Gas Cloud Harvester I, etc.

General Fittings : 1MN Monopropellant Enduring Afterburner, 5MN Microwarpdrive I, Damage Control I, Data Analyzer I, 'Halcyon' Core Equalizer I, Hornet I, Micro Auxiliary Power Core I, Mining Laser Upgrade I, Warp Core Stabilizer I, Warp Scrambler I, Target Painter I, Warp Disrupt Probe, Stasis Webifier I, 1MN Y-S8 Compact Afterburner, etc.

- c) All members are free to enjoy all the goods available at “Kon-Tiki Pub & Bistro”.
- d) All members are free to use blueprints available at “Nicola Tesla Blueprint Archive”.
- e) All members are free to read the books and manuals, as needed, from the “Henry the Navigator Library”.

Books for Explorers : Archaeology, Astrometrics, Hacking.

Books for Miners : Mining, Mining Frigate, Reprocessing.

Books for Industrialists : Industry

General Books : Minmatar Frigate, Minmatar Industrial, Reprocessing, Spaceship Command.

Article 2 – Capsuleer Activity

- a) Capsuleers are encouraged to participate in Wormhole activities as well as Chat.
- b) If a Capsuleer is inactive for over a month without just cause, he/she will be expelled to maintain an active and thriving corporation. Exemptions granted through a prior notification to CEO.
- c) Hi Sec activities and Mission Running are encouraged - however, Capsuleers should remain active in Chat and help Wormhole operations, if they are able to do so.
- d) Mapping J51248 (Hope) is joint duty of all members.

Article 3 – Natural Resources

- a) All loot gathered from any data, relic, combat or ghost sites including salvage materials of any kind belong to the member to use or sell as he/she wishes.
- b) All gas in J51248 belongs to the Exploration Movement. Please help with gas mining if you are able. This gas, is to be deposited into the Mining container of our Athanor station (Alchemist's Crucible)
- c) Ore mined in Wormhole should be deposited in Mining container of our Athanor for reprocessing. Members may reprocess for free here. Please return processed ore from Item Hangar to Mining or Materials for communal use.
- d) In fleet operations, it is the duty of fleet commander to ensure Loot/ISK is distributed fairly amongst fleet members.

Article 4 – Corporations Fees

- a) Fees are billed on a monthly basis and have to be paid within the first five days of the related month.
- b) Capsuleers aged:
 - between 6 months - 1.5 years old should deposit 10 M,
 - between 1.5 years old - 3 years old should deposit 25 M,
 - between 3 years and 4.5 years old should deposit 40 M,
 - over 4.5 years should deposit 55 M ISK per Month into the Corporations account.
- c) Capsuleers whose age are between 0 - 6 months, do not have to pay any remuneration in return for any expenses and can benefit from all services for free.
- d) These fees help to keep the Corp running and may be deferred through services to Exploration Movement.
- e) Capsuleers who defaults paying their Corp fees for two consecutive months without any just cause, shall be expelled from the Corporation.
- f) The Board of Directors has to announce, how the ISK gathered from members used, on a quarterly basis.

Article 5 – Shares

- a) All members are entitled to get 100 shares of Exploration Movement.
- b) Board of Directors will announce, how to pay dividends to the shareholders in three months.

Article 6 – Enactment

This Law shall come into force upon the approval of CEO and take effect in the 1st day of April 2018.
