It should only be used for student placement and measuring progress. A better measurement would be students applying their skills to real-world scenarios. TEACHER EVALUATION: test scores should only matter a fraction, and we should hear what educators and administrators have to say on the matter. Most effective bureaucracies are run from the ground level. SALARIES: There should be an incentive program for teachers who stick it out for the long term, and I would have no problem supporting a bill that raises the floor for teachers with experience, so long as there is also an ability to raise or incentive program based on merit as well. ACCOUNTABILITY: should be handled at the district level, I believe our legislators could get more done if they worried about their responsibilities instead of the responsibilities of others. HEALTH CARE: should give educators a multitude of options and put them in charge of the decisions that rule their life. (hesitant to make a platform issue on insurance because it depends on what happens in Washington) TRS: allow teachers to opt into a 401k but would not support if that was the only option. 401ks offer better chance for increased benefits but also have much higher risks and the state shouldn't make that choice for our educators.

House District 13	Cecil Webster BLOCK VOTE	D	Friendly	FUNDING: One of the most fundamental requirements we have as a state and as citizens is to ensure our youth are prepared for and are capable of leading our nation into the future. A first-class public school education ensures that every student has the opportunity to learn, grow, and thrive. Their success is our success; their failure is our failure. Over the last decade, the Texas Legislature has under-funded our public schools education, thereby limiting our student's potential. I strongly encourage of legislators to right this wrong by increasing and protecting the funding for public schools. This will be my top priority, if elected as state representative. PRIORITIES: As mentioned in Q1, fully funding and protecting public schools from budgetary cuts is my top priority. This is followed by (not necessarily in priority order) de-emphasizing standardized testing where too much focus is placed on passing the testing instead of learning how to apply the concepts learned to everyday living; ensuring teachers are adequately compensated for the tremendous responsibility they have to us and to our students; and ensuring the Teacher Retirement System, including healthcare, for both active and retired teachers is solvent. VOUCHERS: For some students, private and charter schools are a viable option, and I support a parent's and student's right to avail themselves of the educational services offered by these institutions. However, I vehemently oppose any efforts to transfer taxpayers' dollars to these institutions, either through vouchers, tax credits, or any other scheme. CLASS SIZE: Yes, class sizes should be capped. One cap does not apply to all types of classes, however. The tools and method of instruction must be taken into consideration. As for a district getting a waiver on these class size caps, I believe that a district must always have the right to request a waiver, but the granting of a waiver must be by exception, and not the norm. TESTING: I believe standardized testing can be useful in identifying areas needing more focused training, but it should not be used as a major determinant in student advancement from one grade to the next or for graduation requirements. Nor should the students' abilities to pass a standardized test be used as a determinant in teacher pay or performance evaluations. There are too many factors which affects a student's 'success' in these tests that are beyond a teacher's ability to control, including that some students are great 'testers' but poor performers in life, while others are poor 'testers' but have great success in life. SALARIES: Undoubtedly, teachers are a critical resource in any community and should be compensated as such. My belief has been that there are more women teachers than men teachers, and data shows that women are more often underpaid for the services they provide. I believe this is one major factor as to why teachers in general continue to be underpaid, in comparison to comparable professionals. Having said that, I question an across-the-board pay raise for all teachers. I believe locality, specialty, and performance (if properly measured by objective standards) should be considered in determining whether a pay raise is warranted and appropriate. Obviously, some teaching positions are more difficult to fill than others (e.g., STEM vs. humanities) and some localities are more or less desirable than other (e.g., rural and inner city vs. suburban). These considerations must be factored into the amount of increases provided teachers. As to funding these pay raises, both the community and the state have a vested interest in attracting and retaining quality teachers, and both must be involved in providing adequate pay raises. Locally, hopefully, this can be done without property tax rate increases. At the state level, I would support use of the Economic Stabilization Fund (aka, Rainy Day fund) to offset the state's share of this pay increase. Other savings that could be redirected to offset this cost is elimination of the state's funding of state troopers to secure international southern border. Currently the state is spending \$800M on this federal obligation. I'm sure a more in-depth analysis of the state budget could yield further savings that could be used as well. HEALTHCARE: The unchecked rising cost of healthcare is not just a teacher problem, it is a national problem. Every citizen deserves access to affordable and quality health. I do not believe that the government, at any level, should seek to directly control these costs in the free market system we enjoy, but the government does need to be more aggressive in negotiating such services for its members. TRS: Keep defined benefit and offer the choice of the 401k plan for those who want it.

There are numerous potential revenue sources available to avenues to increase funding for our public education systems, including: - restructuring sales or consumption taxes - dividing up current tax revenues to be more equitable towards education - reversing corporate tax breaks/cuts - increasing taxes on the wealthiest, - raising taxes on products such as tobacco, alcohol, or marijuana - reforming, expanding, and funding the Additional State Aid for Tax Reduction, to allow more districts to qualify. As Colorado in particular has proven, legalizing marijuana and using the tax proceeds to invest more in our education systems can work. It's a conversation we must be brave enough to have, and it's a conversation I'm willing to have in Austin. HEALTHCARE: Healthcare costs remain a concern for too many Texans, especially those working in education. We must reduce out-of-pocket expenses, and that starts by evaluating and changing the healthcare plans offered to educators, retirees, and other public education employees. Legislators can negotiate with healthcare and health insurance providers for further discounts or cost reductions, advocate for expanding the Affordable Care Act, and working towards state-based healthcare solutions that reduce both overall costs and out-of-pocket expenses. TRS: As a member of the Teacher Retirement System, I believe TRS must be maintained as a traditional defined benefit pension plan for all future, current, and retired educators. TRS plays an important role in ensuring our educators have security in their retirement. A 401(k) plan does not provide that security, and would not be an avenue I would explore as a legislator. TRS is a distinct carrot to attract teachers to the profession, so must be maintained and protected. TESTING: I recently got involved with the Transparency in Testing Facebook group, and I would advocate for a bill that helps quantify the costs associated with standardized testing. When testing costs run as high as \$13 billion, it is fiscally conservative as well as budget-sensitive to ensure we spend effectively and achieve intended outcomes. Student test scores should be used as part of a holistic process in evaluating student progress, teacher effectiveness, and school district accountability. In my view, however, I think that standardized testing is not the most effective tool to measure student outcomes, and more conversations should be had with educators, school board members, students, and parents to find the best way of assessing student learning. TEACHER PAY: Absolutely. Teachers are grossly underpaid for the work that they put in, so any bill I can vote on that improves teacher pay I would be in full support. Texas teachers are among some of the most underpaid professional workers in any industry, so it is time that their salaries reflected the key role they have in teaching and raising the next generation. PERFORMANCE PAY: Student performance should be a factor in determining teacher pay, but not the SOLE factor. Teachers can only be as successful as the students who want to learn, and in many situations it should be how teachers turn potential into excellence that should drive teacher pay. Other factors, such as the socio-economic make-up of districts and the role of parents, should be considered when setting teacher pay. VOUCHERS: No. Public education is the best option to educate our students, and no money should be removed from the public system. This is a hard line I would maintain, as any proposal that provides incentives parents to remove students from the public education system, ultimately weakens the institution of public education. PAYROLL DEDUCTION: I would support allowing all public employees to use payroll deductions for their membership dues. Not only will this help reduce their taxable income, but it would make being a part of a union more straight forward. Strong unions built the middle class, and we have seen with the erosion of unions how the middle class has declined. Allowing public employees to use payroll deductions for their membership dues will promote unions and make collective bargaining easier, and allow teachers and other public employees a louder voice in the concerns they all share. DOIs: Districts of Innovation are an important part of our education system. They allow districts to implement new policies and procedures that can help students. While this may be true, however, I have concerns that some school districts could manipulate this designation to avoid certain responsibilities, thus harming student outcomes. I would recommend changes to DOI criteria, and would advocate for certain limitations on the state laws that can be waived - for instance, elementary school class-size limits: the lower the teacher-to-student ratio, the better student outcomes often are - especially that this young and impressionable age. Response to researcher following up on TRS: "I'd add to the TRS part that I would explore options that combine TRS and ERS that ensures all retirees have a livable salary on which to retire. Maintaining two systems - especially two that have a gross disparity hurts more than helps."

While we must have measurements to ensure progress, testing results should be only part of things considered. We should revise the current testing systems and let educators work on those redesigns. Evaluations - teachers are probably the single biggest factor in the success or failure of an education system. Evaluations should be one of our tools to develop better teachers and teaching methods. They should not be primarily to punish or admonish teachers. Student scores should be considered, but in context, and as a smaller part of the evaluation. Evaluations should be heavily based on feedback from students, and the feedback should be structured in two parts: to measure student preferences, and rate teachers on aspects of classroom teaching.
